High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

To continue our preparation for the construction of the HS2 railway, we will be closing a section of Gilson Road to undertake important utility diversions.

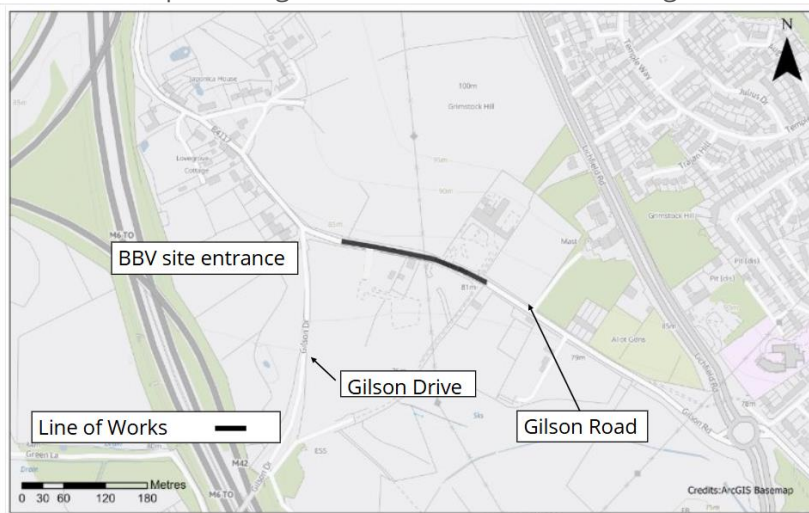
When the work will take place

Further UPDATE: Due to changes in the program the traffic management on Gilson Road will change.

Two-way temporary traffic lights are now in place on Gilson Road and will remain until 6pm Tuesday 20 February. These traffic lights will be supervised from 7:30 to 6pm each weekday.
