









# **Update: weekend works in Euston Approaches site – June 2025**

High Speed Two (HS2) is the new high speed railway for Britain.

#### Overnight and weekend working - June 2025

We will be reinforcing some containment units on Granby Terrace Bridge, overnight on **Saturday 28 June, from 1am to 5am**.

We will also be modifying some hoarding, north of Granby Terrace Bridge, close to the Network Rail tracks. We will work **8am to 8pm** on **Saturday 28 June**.

We can only carry out the reinforcement works and hoarding modifications when the rail tracks below are not in use. We have chosen the quietest methods possible for this work to reduce impact to neighbours.

We will minimise noise impacts where practicable and we will continually monitor noise levels to ensure we are working within the approved limits. We apologise for any disruption these works may cause.

## Ongoing surveys and monitoring at track-level within the Euston Approaches

We carry out regular surveys and monitoring of the bridges and structures within the railway cutting, to inform and assess the impact of our works. For safety, due to the location of these structures beside, above and below the railway tracks, we can only carry out these surveys when the tracks are not in use. This means we frequently carry out surveys during weekends and overnight shifts.


#### Wall removal within Euston Cavern area - 28 and 29 June

We previously informed you that we will work on the weekend of 21 and 22 June to remove a small wall, in the Euston cavern area, close to the Network Rail tracks. We will now use the contingency weekend and work on **Saturday 28 June** and **Sunday 29 June**, from **8am to 8pm**. We will use hand tools and do not expect these works to be noisy. We can only carry out these works when the rail tracks are not in use.

### Hoarding maintenance on Hampstead Road - 28 to 29 June 2025

We carry out regular maintenance to our site hoarding once a month on a Saturday night. We will carry out this work overnight on **28 to 29 June**. We will temporarily close the northbound lane on Hampstead Road and maintain two-way traffic in the southbound lane. You may notice brief periods of noise as we clean the road and hoarding. We apologise for the inconvenience these works may cause.
