What are we doing?

Throughout 2024, we have been constructing the temporary realignment of Bacombe Lane (Bacombe Lane Link Road) to allow for the construction of the Wendover Green Tunnel. The temporary road has now been constructed and is connected to the existing Ellesborough Road.

From December 2024, access to Bacombe Lane from South Street will be closed for two years while the temporary realignment is in operation. Residents access will be maintained on the existing Bacombe Lane via the new link road from Ellesborough Road.

Pedestrian and cyclist access will not be maintained through the closure. Access to allotments will be maintained.

When will these works take place?

Monday 9 December 2024 – Tuesday 1 December 2026

Should the works finish earlier than planned, we will open the road where practicable

These dates may be subject to change due to circumstances outside of our control but works will be completed in or around the set timeframes.
