What are we doing?

For one week in January there will be a lane closure on Station Road North which will be controlled by temporary traffic lights

This is to construct a dropped kerb for resident access.

This is for reasons of safety, as our operatives will be working on and around the carriageway.

When will these works take place?

The lane closure on Station Road North will be controlled by temporary traffic lights and will be in place from Monday 13 January until Friday 17 January 2025.

These dates may change due to conditions outside of our control, such as weather. Please refer to the HS2 website regularly to check for any changes and updates.

Lane closures will be in place on Station Road North from Monday 13 January 2025 to Friday 17 January 2025. These dates are included on the following map.

Manage any environmental impacts, such as traffic and noise.

Respond promptly to any complaints and take appropriate action.

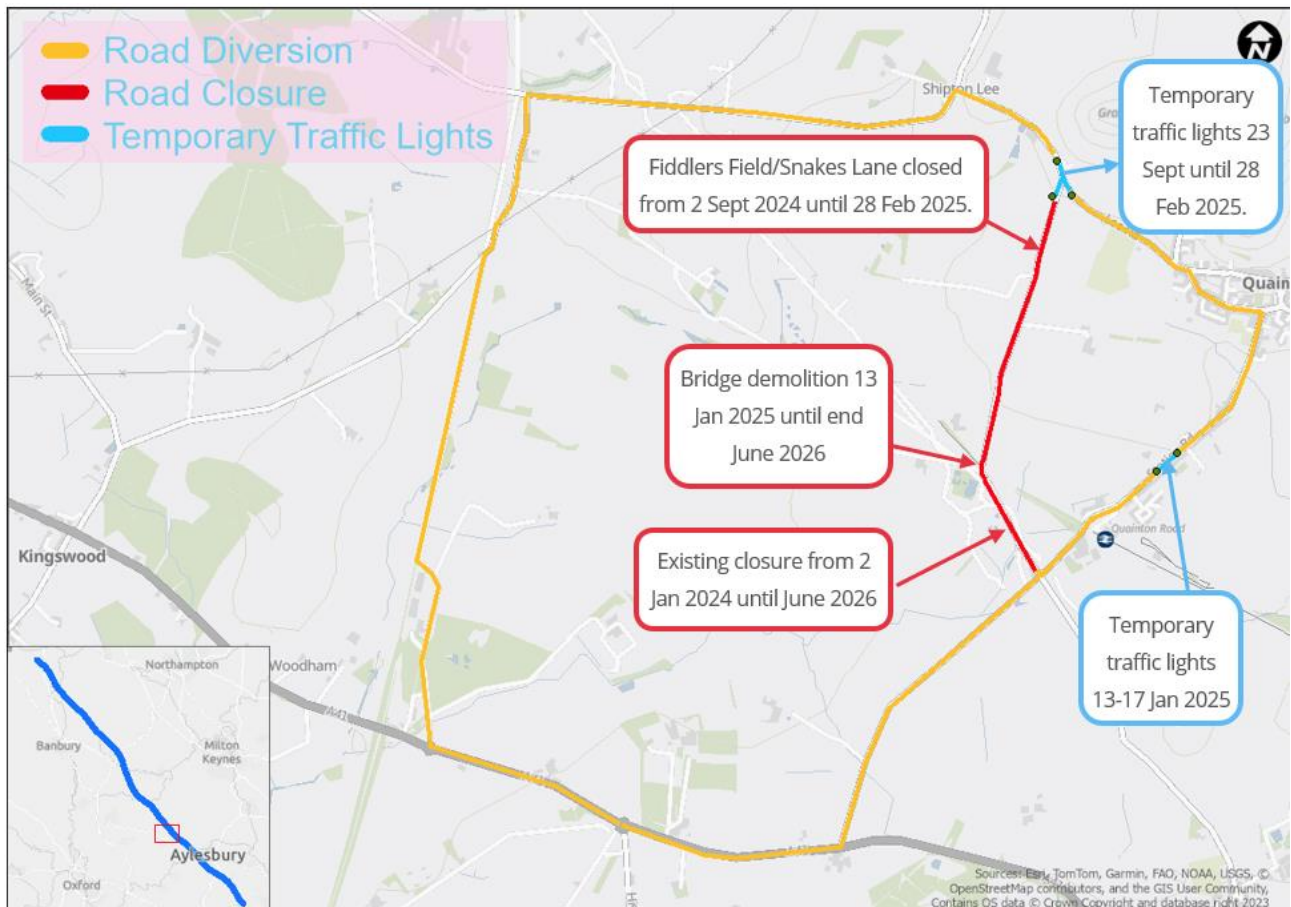

The map below shows the lane closure on Station Road North with temporary traffic lights. This lane closure, which will be managed by 2-way lights, will take place between 13 January 2025 until 17 January 2025. The map also shows the existing Fiddlers Field closures and traffic management on Lee Road/Claydon Road.
