





# Update of removal of site drainage at Mandeville Road Vent Shaft site

High Speed Two (HS2) is the new high speed railway for Britain.

#### What we are doing

We wrote to you in January 2025 to let you know we will be removing ground drainage pipes from the southern side of the Mandeville Road Vent Shaft site. Due to delays in finalising permissions for these works, they will now be carried out from **10 March** to **18 April 2025**.

A saw will be used to cut the concrete surface. An excavator will then be used to break out the remainder of the area. Once the drainage is removed, the excavation will be backfilled with concrete. We will use an excavator and a vibrating plate to level the ground.

#### How this will affect you

You may experience increased noise and vibration during these works. We will use noise reducing barriers where possible.



We would like to apologise for any disruption or inconvenience this work may cause. Every effort is being taken to ensure that these works are carried out in the least impactful way.
