



# Notice of works on Attleboro Lane

High Speed Two (HS2) is the new high speed railway for Britain. We are writing to make you aware of the next stage of work that will be undertaken by Severn Trent Water that is related to HS2.

## What we are doing

Severn Trent has been asked to construct a new wet well pumping station and 1.8m diameter valve chamber, including a controls kiosk, telemetry system, power supply, an anti-septicity dosing unit as well as all pipework within the proposed pumping station.

The project will be located just outside the HS2 construction on Attleboro Lane. The existing sewer requires lining, for this tankering equipment & a lining crew will be required on site. Traffic Management will be required to enable this.

Severn Trent has a responsibility for delivering water and sewerage services to homes and businesses across the region and to ensure the impact of any work is kept to a minimum.

## How this will affect me

The work will generate a small amount of noise and dust, but we will do our best to keep this to an absolute minimum.

There will be no impact on your water or sewerage services.

### Duration of works

The works will begin on Wednesday 12 February 2025 with completion by Thursday 20 February 2025.

Our working hours will be 8am to 6pm Monday to Friday and 8am to 1pm on Saturday, although our staff may be on site one hour before and one hour after to set up and take down equipment.

### What we will do

- If you are directly impacted by the work, Severn Trent will speak with you before it begins to ensure access is not impacted.
- At no time will your water or sewer services be interrupted. We will complete the work as quickly as possible to avoid disruption and provide you access throughout.


## About our Community and Business Funds
