HS2: Maintaining Monitoring Equipment

Old Oak Common Lane | January 2025

High Speed Two (HS2) is the new high speed railway for Britain. BBVS is the contractor working on behalf of HS2 to construct the Old Oak Common Station.

What are we doing

As part of our ongoing essential maintenance works at Old Oak Common Station, we need to ensure that our monitoring equipment on the Great Western Mainline bridge on Old Oak Common Lane is operating as we expect. The purpose of the equipment is to measure the movement of rail bridges during our works.

In order to do this, we need to close a northbound lane of Old Oak Common Lane on **Saturday 4 January 2025 between 1:30am and 4:30am** for approximately one hour. The footpath will also be closed; however, pedestrians can still travel safely through controlled zones.

The location of the work is shown on the map on page two.

These works are subject to approvals from the local authorities and therefore dates could change. We will let you know of any changes via the HS2 website and email notifications.
