



Notice of temporary off-peak A452 southbound slip road full closure and A446 southbound single lane closure

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

A new high-speed railway station is being built within Solihull, near the M42, A45 Coventry Road and A446, close to the NEC and Birmingham Business Park.

As part of the new road network required for the new interchange station within Solihull, works will begin this year on the realignment of the A452.

In preparation for this work, we need to undertake some vegetation clearance to provide the safe working areas for our workforce and the realignment.

To carry out these works safely, we will need to close the entry slip from the roundabout connecting road users to the A452 southbound carriageway and the entry and exit from Packington Lane.

We will also place a single lane closure on the A446 southbound carriageway during off peak weekdays (Monday to Friday) from Monday 10 February until Friday 28 February, these be in place between the hours of 9.30am and 3.30pm.

Packington Lane Access

- **A446 southbound Packington Lane access**

During these works the A446 southbound access onto Packington Lane will be closed during off peak weekdays (Monday to Friday) from Monday 10 February until Friday 28 February between the hours of 9.30am and 3.30pm. Access to Packington will be via the A452 northbound only, following the signed diversion route.

- **A452 southbound Packington Lane exit**

During these works the Packington Lane exit onto the A452 southbound carriageway will be closed during off peak weekdays (Monday to Friday) from Monday 10 February until Friday 28 February between the hours of 9.30am and 3.30pm. Road users wishing to exit Packington Lane onto the A452 southbound, will need to travel under the A452 and head northbound joining the signed diversion route

Duration of works

A446 southbound partial single lane closures and A452 southbound on slip closure (weekdays Monday to Friday only) from **Monday 10 February** until **Friday 28 February** between the hours of 9.30am and 3.30pm.

What to expect

Single lane closure on the A446 Stonebridge Road southbound carriageway.

A452 southbound slip road closure.

Packington Lane A446/A452 southbound access and exit temporarily closed.

Low level noise from our work.

A452 southbound Link Road diversion

Road users wishing to travel southbound on the A452 from the roundabout should follow the diversion onto the A446 northbound, to the M6 junction 4 roundabout (Coleshill Interchange). Traffic will take the fourth exit and follow the A446 southbound for approximately 1.4 miles where the diversion will end.

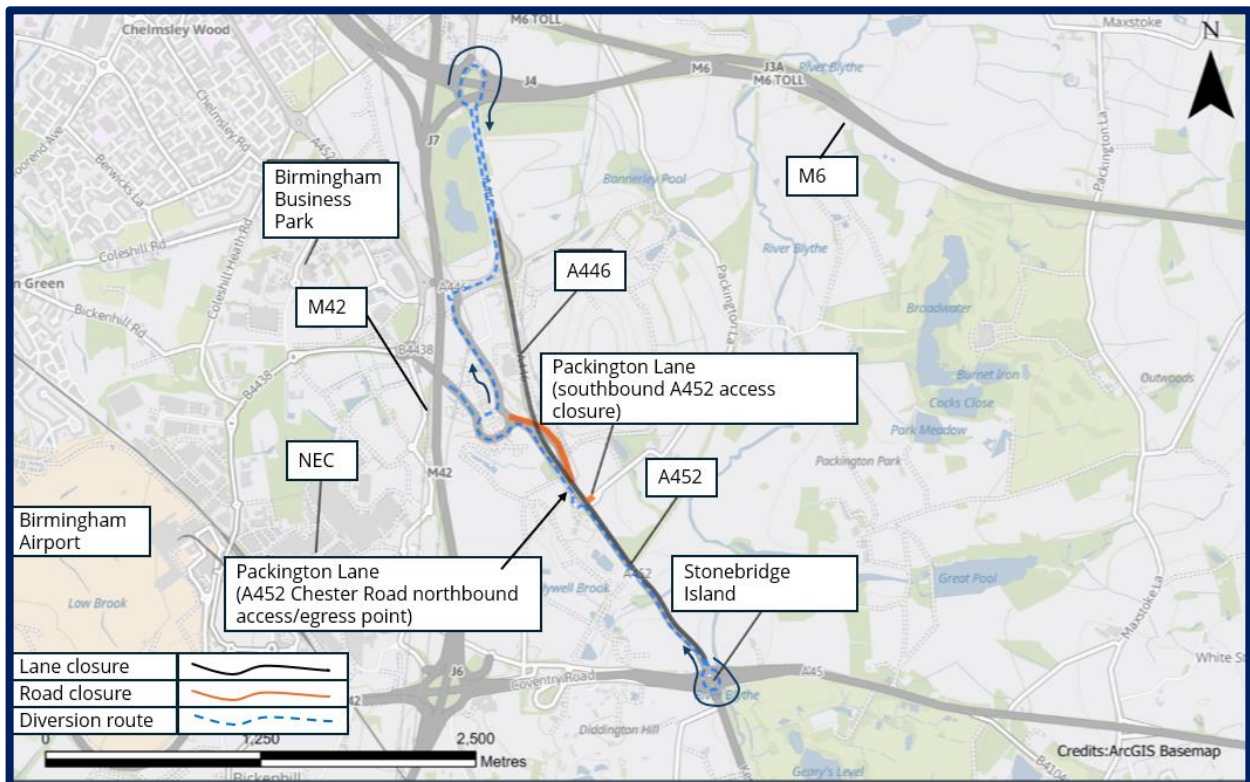
Packington Lane A452 southbound access diversion

Traffic wishing to access Packington Lane via the A446 southbound should continue onto the A452 southbound towards Stonebridge Island, taking the fourth exit onto the A452 northbound until reaching the A452 Packington Lane, where the diversion will end.

Packington Lane A452 southbound exit diversion

All traffic wishing to exit Packington Lane onto the A452 southbound, will need to travel under the A452 and head northbound joining the signed diversion route

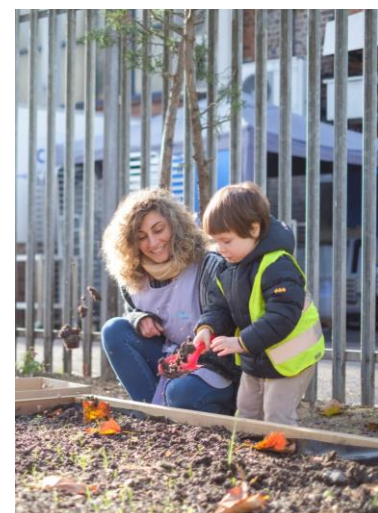
About our Community and Business Funds
