What are we doing?

From mid-January Station Road North will be closed. This is to complete the road crossings and utilities connections of the Thames water mains.

This is for reasons of safety, as our operatives will be working on and around the carriageway.

When will these works take place?

From 25 January 2025 until 14 March 2025 Station Road North will be closed with signed diversion routes in place.

These dates may change due to conditions outside of our control, such as weather. Please refer to the HS2 website regularly to check for any changes and updates.

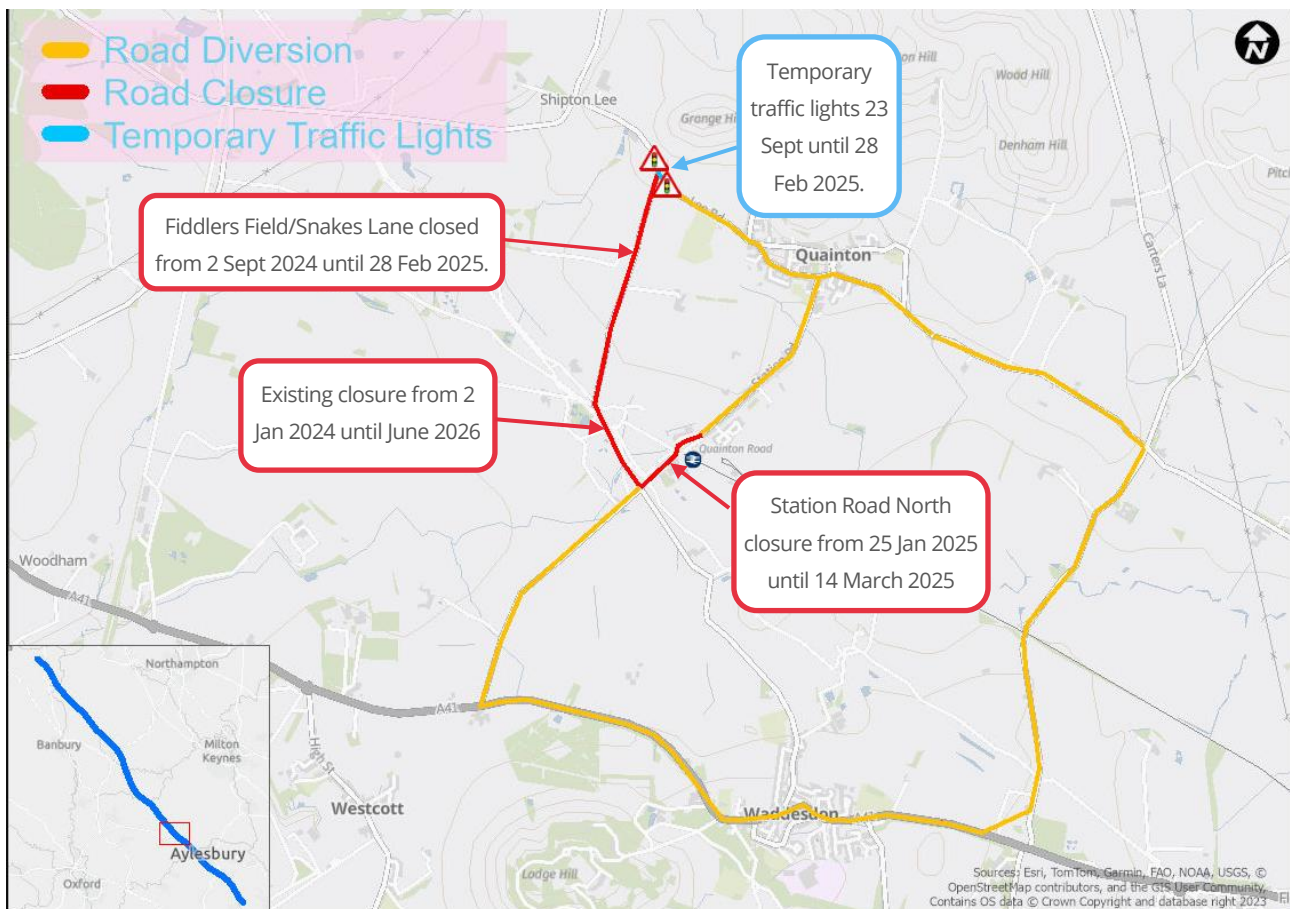
