What are we doing?

As part of the A41 realignment, we have been narrowing a section of the old Bicester Road (formerly the A41) since Autumn last year. This work will continue until March 2025 when it will reopen on the newly narrowed road layout.

From early February 2025 we will also be narrowing the middle section of this road which includes the junctions with Waddesdon Hill and Blackgrove Road. The old road surface will be removed and rebuilt according to the new narrowed design.

As such, these works will take place under a 24 hour road closure with a signposted diversion route in place. Due to the nature of the works, there will be no access possible through the closure.

We will then be narrowing the remaining section of the old road between The Waddesdon Hill junction and the Fleet Marston temporary roundabout. This road will be permanently stopped up near the Fleet Marston temporary roundabout and will cease to be a through road.

When will these works take place?



- 8:30am Friday 7 February 8:30pm Tuesday 4 March, full road closure of Old A41 Bicester Road, Waddesdon Hill and Blackgrove Road junctions.
- 8:30pm Wednesday 19 March, full road closure of Old A41 Bicester Road section between Fleet Marston temporary roundabout and Cranwell Farm.

These dates may change due to conditions outside of our control. Please refer to the HS2 website regularly to check for any changes and updates.

Where will these works take place?

The maps below show the section of the old A41 Bicester Road and the junctions with Waddesdon Hill and Blackgrove Road which will be closed between 8:30am Friday 7 February – 8:30pm Tuesday 4 March and the approved diversion route. It also shows the section of the old section of A41 Bicester Road which is currently closed and will also re-open from 4 March 2025.

*Note: Due to the road surface being removed and rebuilt, no emergency access will be possible through the closures.





The map below shows the section of the old A41 Bicester Road which will be permanently closed from 8:30pm Wednesday 19 March. It will be permanently stopped up near the Fleet Marston roundabout and will cease to be a through road. It will provide residents access only.
