## What are we doing?

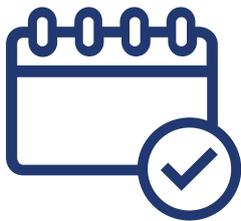
In February, we will be adding road priorities at two junctions along the new A418 Oxford Road alignment.

We will be carrying out 'white lining' works and installing signage under temporary traffic management over the course of 2 days at two different locations on the new road alignment.

It will be necessary to carry out these works under traffic light controlled lane closures for approximately 60 minutes each day. This is for reasons of safety. This will occur during off peak hours to minimise disruption.

Most of the work can be carried out without the need for traffic management and every effort will be made to keep holds on traffic to a minimum.

## When will these works take place?



- **Monday 3 February, 2-way traffic lights possible between 9:30am-3pm**
- **Wednesday 12 February, 2-way traffic lights possible between 9:30am-3pm**

These dates may change due to conditions outside of our control. Please refer to the HS2 website regularly to check for any changes and updates.

Provide updates for communities and maintain regular contact points for the duration of the work.

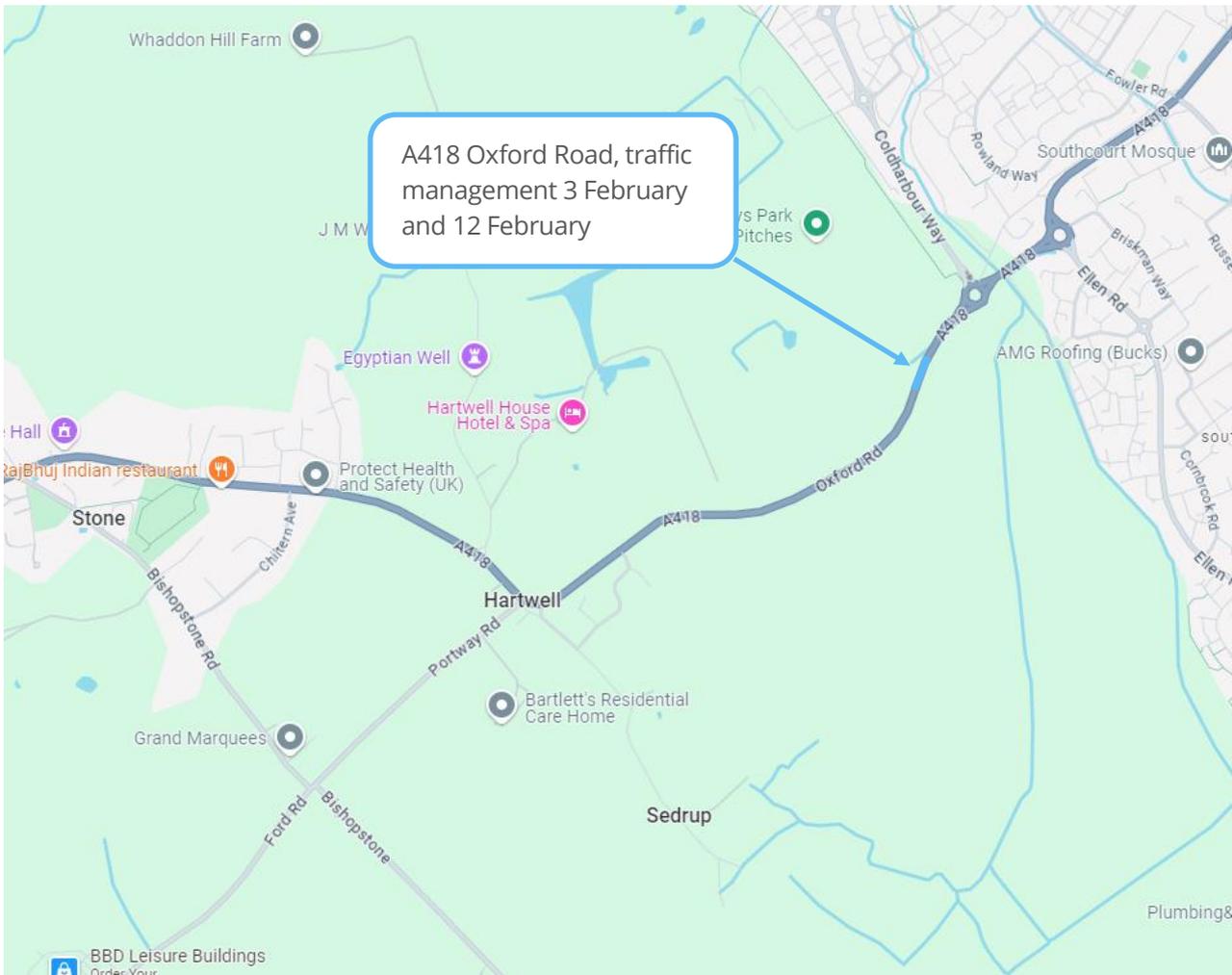
