High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

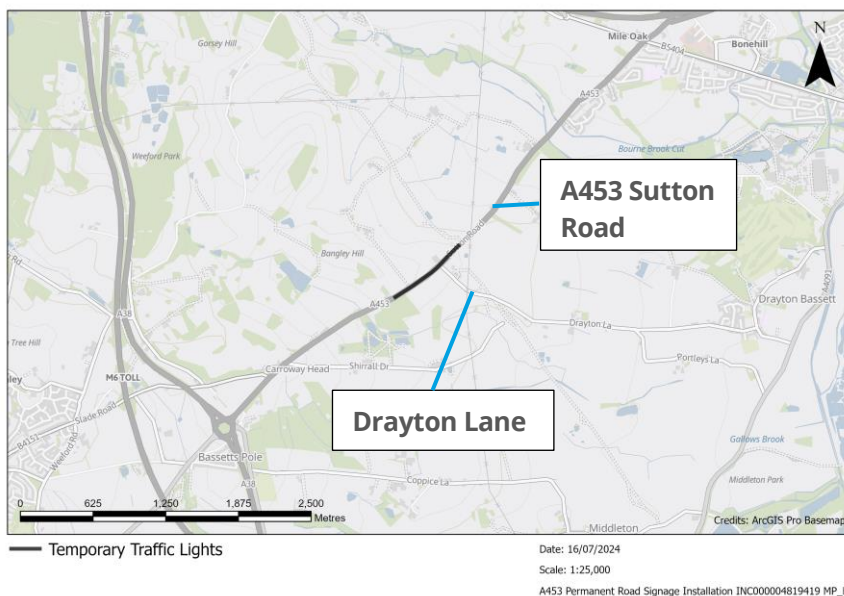
The work we are completing

We recently created a temporary diversion on the A453 Sutton Road; to allow for future construction works, this will enable the new railway to pass underneath A453 Sutton Road. The new temporary diversion will minimise impact on the road during construction.

To enable us to complete these works we will require temporary overnight traffic management on A453 to complete installation of permanent traffic signage and to conduct surveys.

When the work will take place

To minimise disruption, the work will take place overnight. We will have temporary traffic lights in place between **8pm** and **6am** from 17 February until 18 February 2025.
