High Speed Two (HS2) is the new high speed railway for Britain. Mace Dragados is the Construction Partner building the new HS2 station in Euston.

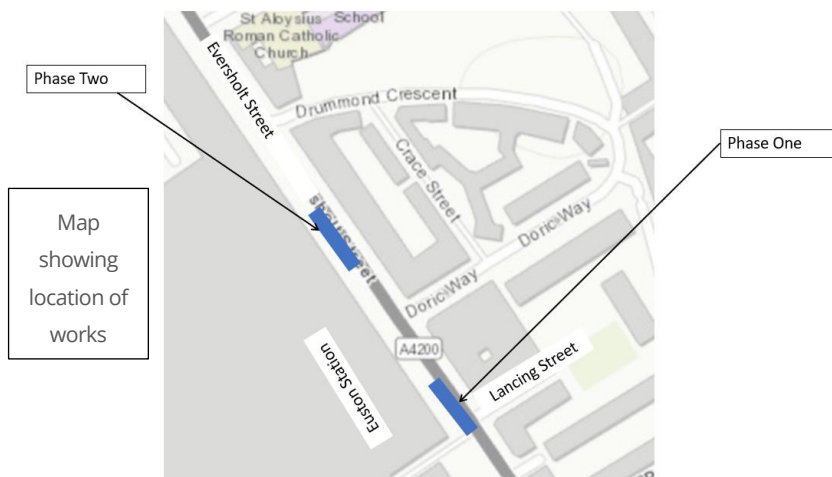
### CCTV Investigative Gas Works

As part of our essential utilities programme, we will be conducting CCTV investigative works on **Eversholt Street**. These investigations will help determine the future programme for the new gas main connection and other utility works in the area. These works will commence on **Monday 10<sup>th</sup> March 2025** and is anticipated to be completed in late April 2025. **Working hours will be Monday to Friday, 8am to 5pm.**

### Work Phases and Traffic Management

Works will be undertaken in two phases. During phase one of the works **bus stop A will be suspended**, and during phase two of the works **bus stop B will be suspended and private hire vehicles will not be permitted to drop off or pick up passengers** around our site on Eversholt Street. Please visit [www.tfl.gov.uk](http://www.tfl.gov.uk) for alternative stops and routes.

Both phases of works will require a **northbound lane reduction with vehicular traffic being controlled by temporary traffic lights**. Pedestrian access and safe crossing points will be maintained throughout the duration of these works.



We recognise that construction work can be disruptive to those living and working nearby. The nature of our work often means some disturbance is unavoidable, however every effort is made to minimise any unnecessary noise.

**Please be aware the timeframe given above is a guide and that programme rephasing may mean the timings can change.** If these changes are likely to cause any disturbance, we will write to you again.

### Duration of works

- 10 March 2025 – April 2025
- 8am to 5pm
- Start-up and close-down activities up to one hour before and up to one hour after working hours above

### What to expect

- Temporary worksites where work is taking place
- Traffic management in place
- Pedestrian access will be maintained

### What we will do

- Aim to reduce noise and vibration as reasonably practicable
- Keep all sites safe and secure
