High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

To continue our preparation for the construction of the HS2 railway, we will be closing a section of Gilson Road to undertake important utility diversions. These works are being undertaken in phases. **Phase 1** will be complete on 18 February 2025

When the work will take place.

Phase 2 To complete these works safely, we will install a full road closure along Gilson Road, 24 hours a day, seven days a week each weekday from 7:30am Monday 3 March to 5:30pm Sunday 30 March.

Access to properties and a pedestrian route will be maintained throughout the closure.
