High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

To continue our preparation for the construction of the HS2 railway, we will be installing temporary traffic lights on Lanchester Way/Rover Drive, Solihull. These works are to undertake drainage surveys.

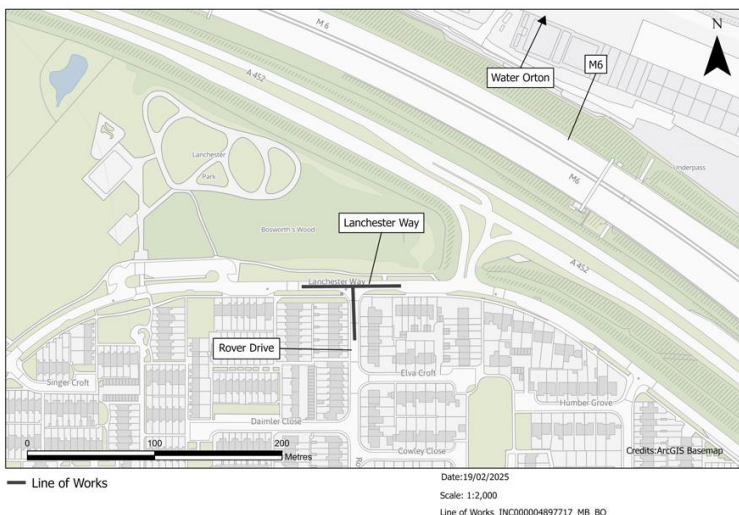
When the work will take place

To complete these works safely, we will install three-way temporary traffic signals controlling traffic movements at the junction of Lanchester Way and Rover Drive. The width of the road of Rover Drive will be restricted to a single lane traffic.

The works will take place on Tuesday 18 March 2025. To control traffic flow and avoid rush hour, our working hours will be from 9:30am to 3:30pm.
