High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

CCTV Surveys

We will be carrying out CCTV drainage surveys along Crawford Street. These will take place on Sunday 16 March between 8am – 4pm.

Drainage inspections are non-intrusive surveys and help us plan which utility diversions need to be carried out. During these surveys we will need to excavate to locate the sewer. A sewer camera will be used to examine the underground pipes and then the excavation will be backfilled.

Road closure

To be able to carry out these surveys safely and effectively, we will need to put in place a temporary road closure. Access to businesses will still be permitted if required during these times.

Map of underground surveys on Crawford Street, Birmingham

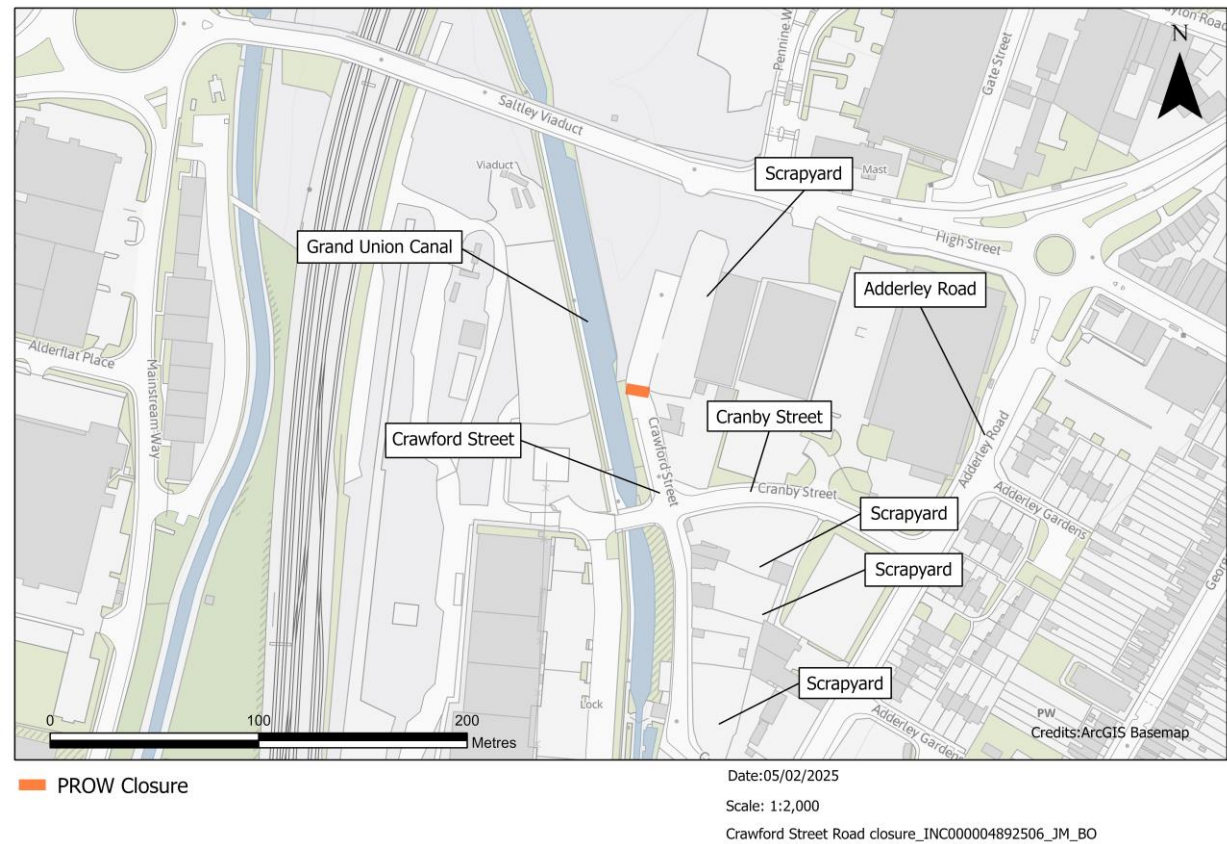
