What we are doing

From 26 February to 21 March 2025, we will be working on the footpath along Harvil Road, between the Dogs Trust and Skip Lane.

We will carry out the following activities:

- connecting water supply to the headhouse
- replacing damaged edges and reinstating surroundings
- repairing paving defects and cracks, including removal of graffiti
- landscaping, including grass seeding.

These activities will be carried out along and around the footpath on Harvil Road. A footpath diversion will be in place and maintained by traffic marshals.

We would like to apologise in advance for any disruption or inconvenience this may cause. Every effort is being taken to ensure that these works are carried out in the least impactful way.

We will ensure that disruption is kept to a minimum.
