What are we doing?

EKFB regularly carry out safety inspections on and around our sites. Following a recent inspection, we need to remove some vegetation along A425 Leamington Road.

Our staff will be working in the carriageway and to complete this work safely, a off-peak one-day road closure is required.

A signed diversion will be in place, and the road may be open earlier if the work is complete, and it is safe to do so.

When will these works take place?

A section of the A425 Leamington Road, Southam near Dallas Burston Polo Club will be closed on Saturday 1 March 2025, from 9am to 3pm.

These dates may be subject to change, due to circumstances outside of our control, such as poor weather.

This work is subject to local authority consents and approvals.

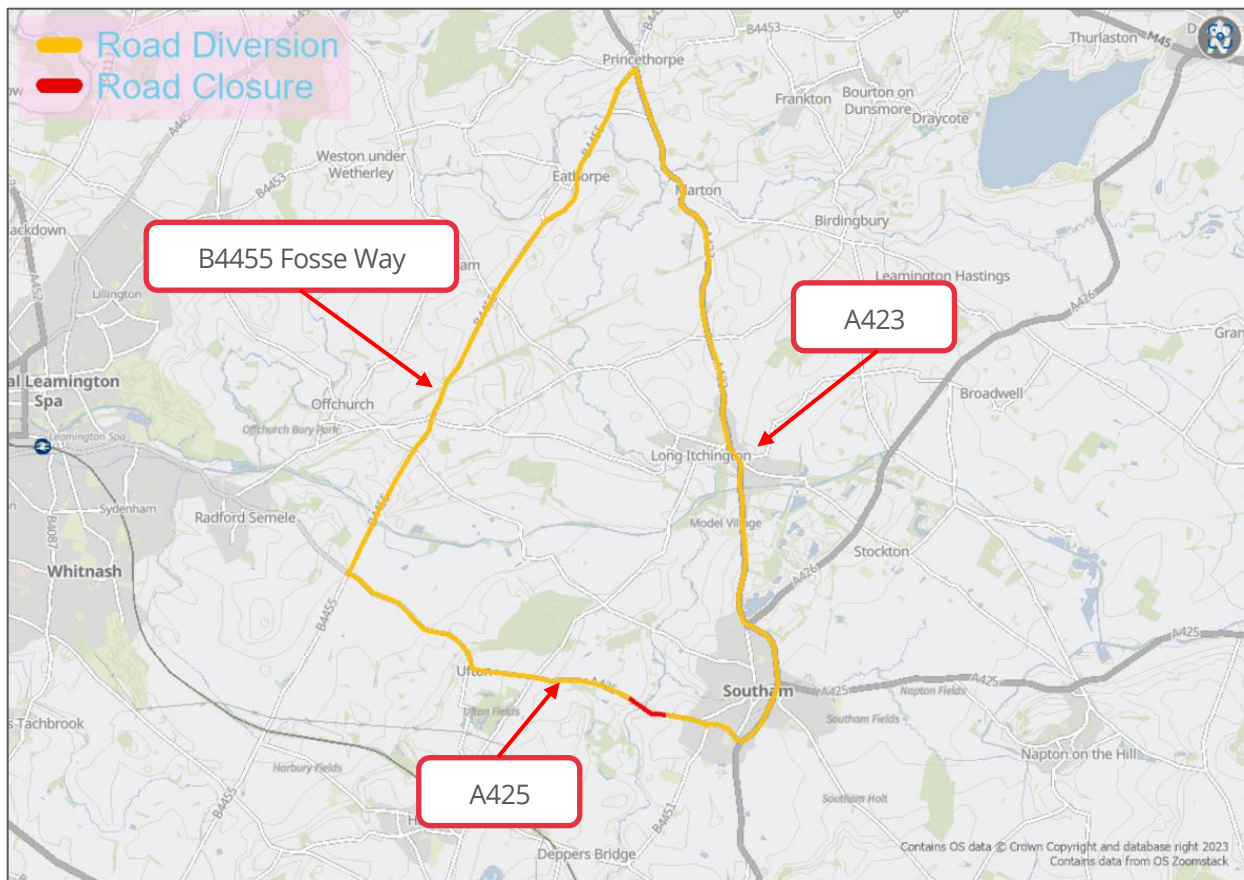
