High Speed Two (HS2) is the new high speed railway for Britain.

What we are doing

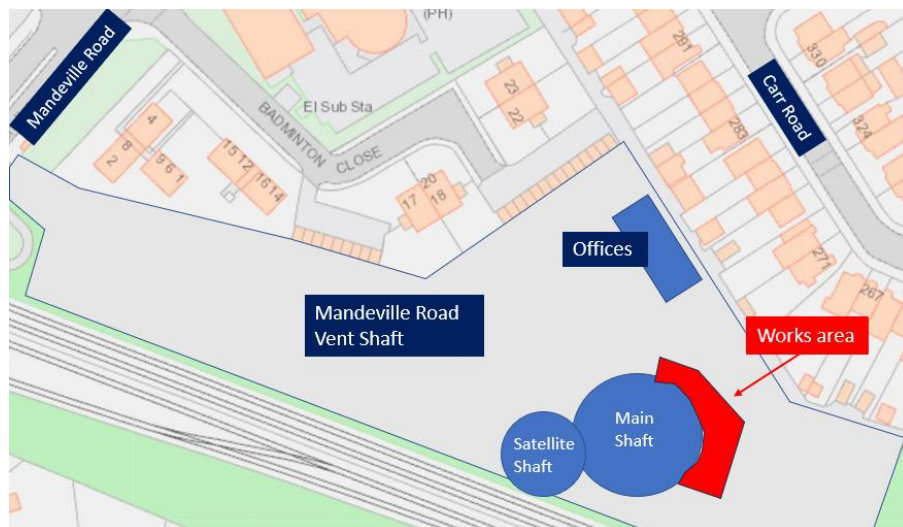
From **10 March to 9 May 2025** we will be breaking concrete near the main shaft at the Mandeville Road Vent Shaft site. This work is to prepare for building the headhouse base slab.

Handheld tools will be used to cut up the concrete surface and a vacuum excavator will then be used to break up the remainder of the concrete.

How this may affect you

You may experience increased noise and vibration during these works. Noise and vibration monitoring will be in place. We will use noise reducing barriers and water sprays to reduce dust.
