High Speed Two (HS2) is the new high speed railway for Britain.

What we are doing

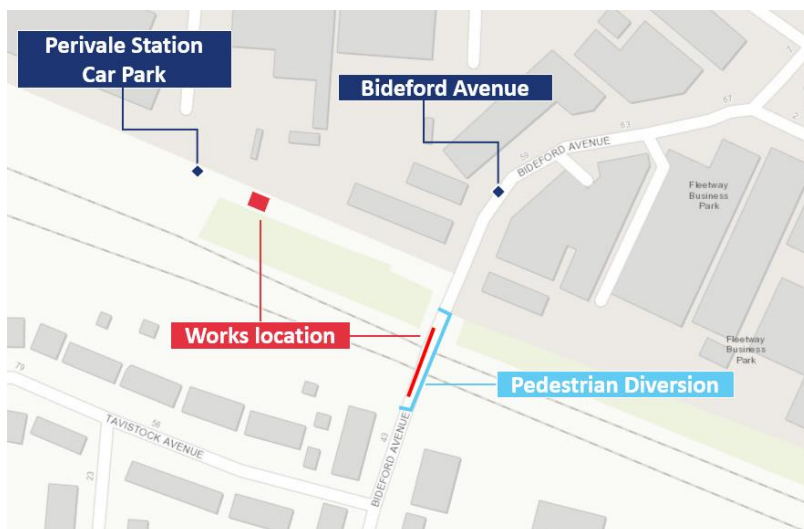
We will be carrying out CCTV surveys on Bideford Avenue and Perivale Station Car Park on **Thursday 27 and Friday 28 February** between **8am and 4pm**. We will need to access the sewer under the ground through a manhole in the road and insert a camera to survey the condition of the sewer. We may need to wash the sewer with a jet washing machine to improve visibility for the camera.

We apologise for any disruption these works may cause.

How this may affect you

There will be a short lane closure under the railway bridge on Bideford Avenue. We'll install temporary traffic lights, a footpath closure and a pedestrian diversion.

You may hear some noise if we need to jet wash the sewer. We will use noise reducing barriers where possible. The approximate location of the work is shown on the map below.
