High Speed Two (HS2) is the new high speed railway for Britain.

Hoarding works on School Road

On **Sunday 23 February, Sunday 2 March and Sunday 9 March 2025**, we will replace and paint our Victoria Road Crossover Box site hoarding on School Road, near the junction with St Leonard's Road.

These works take place on Sundays from 8am to 1pm to minimise disruption to the road network.

Road diversion for vehicles over 3.5 tonnes

School Road will be open during the works for small vehicles. A diversion route will be in place for vehicles over 3.5 tonnes (see map on following page). This is for safety reasons due to operatives working next to the road.

We'll use handheld tools to replace and paint the hoarding. You may hear some noise. We will monitor the works to ensure that any disruption is kept to a minimum.

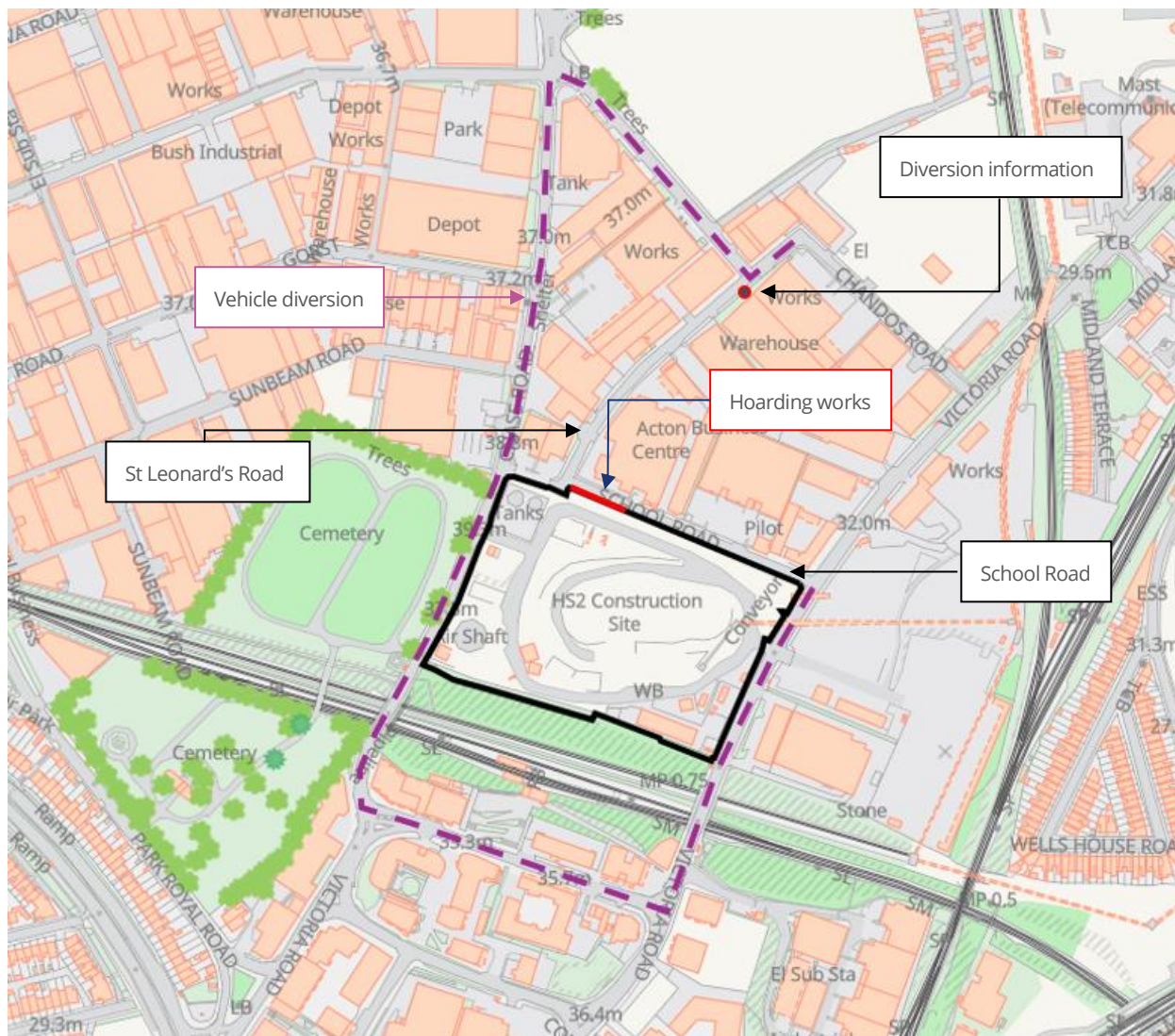
