High Speed Two (HS2) is the new high speed railway for Britain. The health and safety of our workforce and the communities we work within is our priority. You can sign up for regular updates in your local area at www.hs2innorthants.co.uk.

What are we doing?

As we continue to progress the Lower Thorpe viaduct, we will be extending our working hours to include regular Sunday working.

During the additional day we will be focused in specific areas, undertaking activities related to the drainage culvers under and adjacent to the line of the railway.

Noise levels during this work will be closely monitored to ensure they remain within the permitted limits.

When will these works take place?

We will be working seven days a week in this location from 1 March until 31 October 2025, from 7am to 7pm.

Manage any environmental impacts, such as traffic and noise.

Respond promptly to any complaints and take appropriate action.

Subject to local authority consents and approvals, and ongoing review.


Notice of extended working hours at Lower Thorpe, Thorpe Mandeville
