



Notice of road closure on Wood End Lane, Fradley

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

What we are doing

Ahead of constructing the new HS2 structures, we are permanently realigning the junction at Wood End Lane in Fradley. To complete these works, we need to install road closures on Wood End Lane to extend the existing footpath.

Full and temporary road closures

To carry these works out safely, we will need to temporarily close a section of Wood End Lane and install traffic management.

Temporary weekday traffic lights will be operational on Wood End Lane from Monday 10 March to Monday 7 April 2025, 8.00am to 5.00pm.

Weekend working is required from Saturday 29 March to Sunday 30 March and Saturday 5 April to Sunday 6 April, 8.00am to 5.00pm.

There will be a full closure of Wood End Lane from Monday 7 April, 8.00am to Friday 11 April 2025, 5.00pm.

To keep traffic moving in the area there will be a diversion route in place.

Access to properties and businesses within the closures will be maintained at all times.

These are the earliest dates and are subject to change.

Temporary traffic lights (weekdays) - Monday 10 March to Monday 7 April 2025, 8.00am – 5.00pm

Temporary traffic lights (weekends) – Saturday 29 March to Sunday 30 March and Saturday 5 April to Sunday 6 April, 8.00am – 5.00pm

Full road closure - Monday 7 April, 8.00am to Friday 11 April 2025, 5.00pm

Working hours

8.00am – 5.00pm

Our workforce may be on site up to 1 hour before work begins to set up the site and again afterwards to take down our work equipment.
