
High Speed Two (HS2) is the new high speed railway for Britain. Mace Dragados is the Construction Partner building the new HS2 station in Euston.

Ongoing Utility Works

As part of our essential utilities programme, we will continue works on Hampstead Road, Cumberland Market, and Varndell Street.

Thames Water Decommissioning - Cumberland Market and Varndell Street

Following the successful commissioning of the new water main on Cumberland Market and Hampstead Road, we now need to fully decommission the old main. Works on Cumberland Market started on Thursday, 8th May 2025, and works on Varndell Street will started on Tuesday, 6th May 2025. **All works are expected to be completed by late May 2025.**



There will be a small worksite on Cumberland Market, with the road remaining open to vehicular traffic. Additionally, there will be two small worksites on Varndell Street. To facilitate ongoing works on Hampstead Road, Varndell Street will remain closed to traffic. Pedestrian access will be maintained throughout the works.

Duration of works

- 6 May late May 2025
- Works Monday –
 Friday, 8am to 6pm
- Start-up and closedown activities up to one hour before and up to one hour after working hours above

What to expect

- Temporary worksites where work is taking place
- Traffic management in place
- Pedestrian access will be maintained

What we will do

- Aim to reduce noise and vibration as reasonably practicable
- Keep all sites safe and secure
