



## Notice of road closure on B4114 Birmingham Road, Coleshill

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

### The work we will be doing

As part of the ongoing preparations for the HS2 railway construction, we will be carrying out essential construction works to return the B4114 Birmingham Road to its original realignment.

To enable these works to take place a road closure will be in place on the B4114 Birmingham Road from the junction of Manor Drive to the River Cole.

This closure will be the first of three phased closures between the end of April until early September 2025.

### When the work will take place

To complete the works safely, we will install a full road closure along the B4114 Birmingham Road. The works will take place from 7am Monday 28 April to midnight on Sunday 25 May 2025. The road closure will be in place 24/7. All vehicles will be directed to use the diversion in place. Pedestrian access will be maintained.

Road closure of B4114 Birmingham Road from 7am Monday 28 April to midnight on Sunday 25 May 2025.

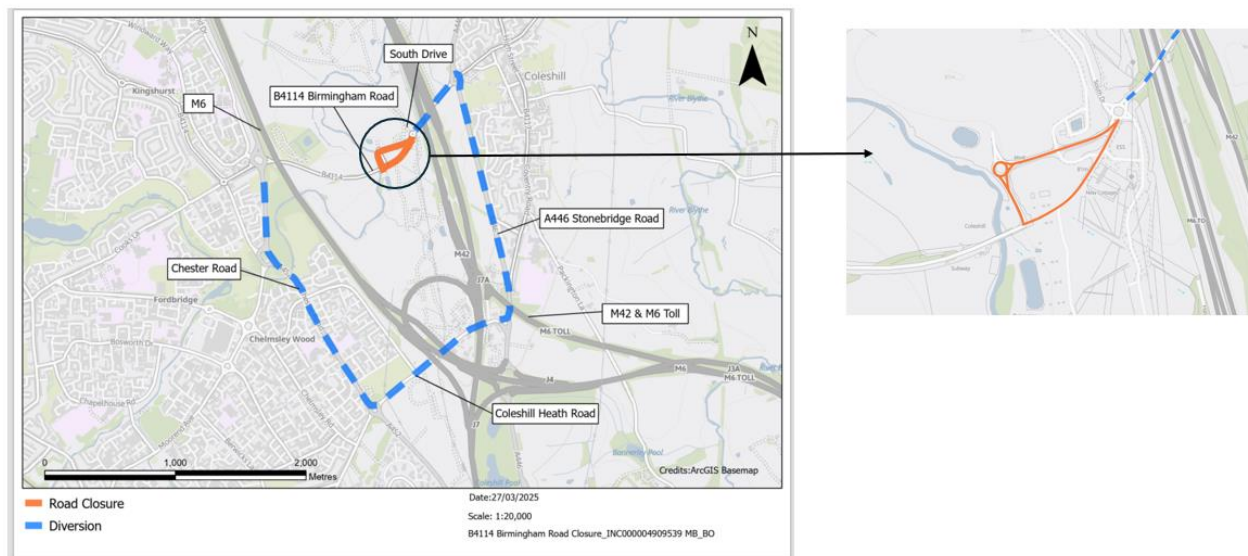

## Map of closure and diversion route

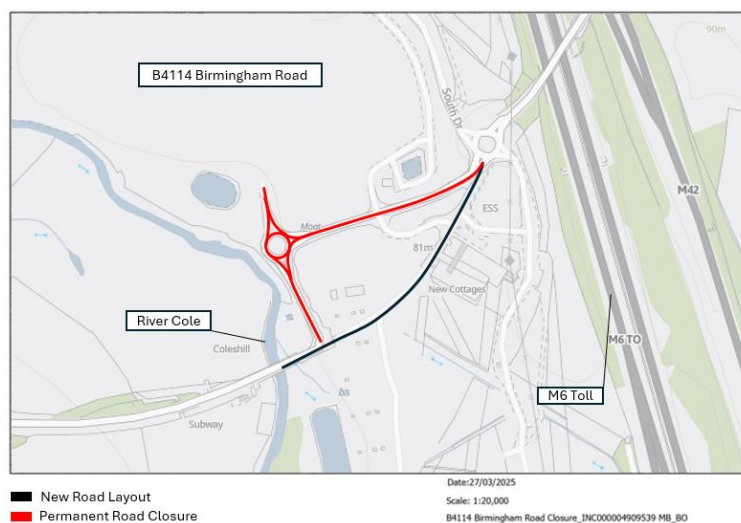
### B4114 Birmingham Road

The westbound diversion route follows the A446 south to Coleshill Heath Road, then continues onto the A452 Chester Road and A452 Collector Road before rejoining the B4114 Birmingham Road, where the diversion ends. The eastbound diversion route follows the A452 Collector Road to the A452 Chester Road, then onto Coleshill Heath Road and the A446 Lichfield Road, before rejoining the B4114 Birmingham Road, where the diversion ends.



## Map of the B4114 Birmingham Road on original alignment

Once the road closure on the B4114 Birmingham Road is lifted on Sunday, May 25, traffic will return to its original alignment. The section shown in red will no longer be accessible to the public but will remain in place. The black line indicates the route traffic will follow after the closure ends.
