High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

To support the ongoing preparation for the construction of the HS2 railway, we will be implementing traffic management on Gilson Road to carry out essential utility works for the new road realignment.

Temporary traffic signals will be in place from the western edge of Gilson village to the junction with Gilson Drive. As the works progress, the traffic management will shift along Gilson Road in sections of 20 to 50 meters at a time. Depending on the specific work area, either twoway or three-way signals will be used to maintain traffic flow.


When the work will take place

To complete these works safely we will install temporary traffic signals on Gilson Road from Monday 31 March and will remain in place until Sunday 1 June 2025. The traffic lights will be in place 24 hours a day, 7 days a week, for the duration of these works.

These traffic lights will be supervised from 7:30 to 6pm each weekday.
