High Speed Two (HS2) is the new high speed railway for Britain. EKFB is working in partnership with HS2 Ltd to build the new high speed railway in your area. You can sign up for regular updates in your local area at www.hs2innorthants.co.uk.

What are we doing?

At the Banbury Road overbridge, near Boddington we are currently installing parapets to the bridge deck and building the foundations for the vehicle restraint system.

We are preparing for the realignment of the Wormleighton Road over the new Banbury Road overbridge. This will advance the construction of the footpath and roadside drainage and help reduce the time required for a full road closure.

To complete these activities there will be a section of single lane traffic, managed by multi-way traffic lights on a section of Wormleighton Road near Stoneton Lane.

When will these works take place?

Update:

Saturday 4 January 2025 until 31 July 2025.

The work is subject to changing weather condition and local authority consents and approvals.


Notice of traffic management, Wormleighton Road, Boddington
