# 4. HS2 Euston area update

**Maddelyn Sutton** 

- **CEOs review** currently reviewing the whole HS2 programme as part of a major reset, making sure the building blocks of the scheme are in the correct sequence
- HS2's approach to spending allocation for 2025/26 ie focus on OOC to Curzon Street: Euston station terminus confirmed by government but current focus is Old Oak Common to Birmingham
- **Update on work in the approaches and start of tunnelling**: Works are being rescheduled on the Euston cavern, Euston crossover tunnels, Euston portal, Euston scissor box and the retained cut. Our shaft and headhouse sites at Adelaide Road and Canterbury Works will remain on pause over the next two years. Tunnel boring works and works to realign Hampstead Road Bridge will continue.
- Continuing with the work to prepare the Tunnel Boring Machines (TBMs) at Old Oak Common to build the Euston tunnel. The TBMs are due to begin their journeys in the next 12 months and will take around 18 months to reach the end of their drive length at Euston.

- Update on station design and works No change from DfT update last year
- Will people notice a difference in terms of the level of works taking place and will these
  continue to be all no regrets similar amount of work as currently and yes work will continue to be
  'no regrets' work
- **Update on MWU spaces** currently looking at meanwhile use spaces to see if we can extend these or look for different uses with the longer duration
- **Euston campus planning:** no change from DfT update
- Likely timing for further DfT announcements if any change from the "second phase of the Spending Review" as quoted by the DfT in its statement last time/gov.uk says this is late spring but we've also been told June]: no change from DfT update

A:

The bus stops are located on the northbound carriageway of Hampstead Road outside the Euston Tower.

The TfL Buses team has confirmed that the stops were reopened on Thursday 6 March 2025. The suspension had been put in place to allow trial holes to be dug for the planned redevelopment of the Euston Tower.




The installation of the expanded space was completed in December 2024, and we celebrated with the young people from Regents Park Estate who co-designed the space in January 2025.

# 8.1 Mace Dragados

#### **Eversholt Street Gas Works - March 2025**



- Surveys are required on the existing gas main on Eversholt Street to inform design.
- Two excavations are required in the northbound lane, and this will be carried out in two phases
- Works begin on Monday 3 March 2025 and will last for approximately four weeks
- Lane restrictions on Eversholt Street with traffic being managed by temporary lights
- Pedestrian access and crossing points maintained at all times



Map showing location of works










# **Hampstead Road – Bus Stop J Remedial Works – 7<sup>th</sup> to 11<sup>th</sup> April 2025**

- Remediation works to bus stop J in the northbound carriageway of Hampstead Road
- Temporary 'dolly' bus stop to be provided for the duration of works, opposite North Gower Street





# **Drummond Street Gas Works – 2025** (dates STC)









- Anticipated May 2025, following Virgin Media works.
- Initial works from 16th May until 4th July will be undertaken utilising localised closures, with full Drummond Street closure starting from May 2025.
- Push gate out into Drummond Street and extend hoarding line
- Full closure of Drummond Street will progress from 07th July 2025 until 10th October 2025.

### **Gas Main Secondary Diversion - Q2 2025** (dates TBC)

Imace DRAGADOS Working in partnership with - 52

- Gas main secondary diversions required on North Gower Street and Euston Street. This will require the replacement of an existing gas main.
- First works include excavations down the extent of Euston Street to replace gas main.
- North Gower Street requires two simultaneous excavations, to be undertaken after Euston Street works.
- Traffic Management to be confirmed and communicated in the coming weeks

Some minor works are required to fully decommission the existing watermain, following the new installation and bringing into use of the new asset. These works will be completed by Thursday 24th April 2025.

#### **Cumberland Market**


Small traffic management in place on Cumberland Market, however, the road will always remain open to traffic. These works will begin Monday 31st March 2025.

#### **Current & Future work**





# Adelaide Road Headhouse & Ventilation Shaft (ARVS)

#### Pause to works

#### What to expect during the ongoing pause to works

In line with direction from the Government following its announcement in March 2023, work at the Adelaide Road site had been brought to a safe stop and paused from spring 2024. As part of an ongoing and comprehensive review of the programme, HS2 are resequencing works at Adelaide Road to ensure they are delivered at the lowest reasonable cost. We do not now expect works to resume in full in April 2025 as planned and are currently updating the works programme.

- Large machinery has been removed from site
- Hoarding and welfare cabins will remain in place
- 24/7 Security presence will continue
- Lighting on site is reduced, but is required for security purposes
- Some works will continue, within and outside the site, including monitoring, surveys, and design work
- Environmental monitoring of noise, vibration & dust is continuing
- The SCS JV engagement team will continue to be available to speak about our works, contactable via the HS2 Helpdesk (operational 24hrs, 365 days)



#### **Euston Approaches works**

As part of an ongoing and comprehensive review of the programme, HS2 are resequencing works in the Euston Approaches to ensure they are delivered at the lowest reasonable cost.

We will continue the works below:

- Extend Granby Terrace bridge
- Network Rail wall demolition and excavation in Euston Throat Retained Cut
- Zone 5 site set-up and piling
- Piling in Euston Throat Retained Cut
- Construct Hampstead Road bridge temporary road
- Extend Hampstead Road bridge
- Ongoing utility diversion works on Hampstead Road bridge and across Granby Terrace bridge
- Protective works to properties
- Instrumentation & Monitoring (I&M) install

We will provide further information once our programme is finalised.

#### Rescheduled works

The works listed below will be rescheduled

- Euston Cavern, Euston crossover tunnels and Euston portal
- Protective works to Mornington Street bridge
- Works in Euston Scissor Cut
- Protective works to the Network Rail retaining wall
