



## Notice of temporary closure of Cromwell Lane, Burton Green

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

Burton Green Tunnel will stretch for 700 metres through Warwickshire at Burton Green and Kenilworth Greenway. The green tunnel will have enhanced environmental features such as extensive tree planting, new footpaths, and better connections to local woods - helping it blend into the natural landscape.

### The work we will be doing.

As we progress construction of the tunnel and road realignment, we will remove some of the temporary piles located under the current Cromwell Lane diversion. To carry out these works in a safe and secure environment we will need to close Cromwell Lane.

### When will these works be taking place?

These works will be carried out from **Monday 12 May to Saturday 31 May 2025**. Please note that the closure will be in **place 24 hours a day** while these works are carried out. A fully signposted diversion will be in place during the closure with access to all properties maintained throughout. Cromwell Lane will remain open for pedestrians and cyclists.

These works will be followed by utility diversion works that will be undertaken from late Spring and throughout 2025. We will share further communications on these works once the dates are confirmed.

Fully sign posted diversion will be in place

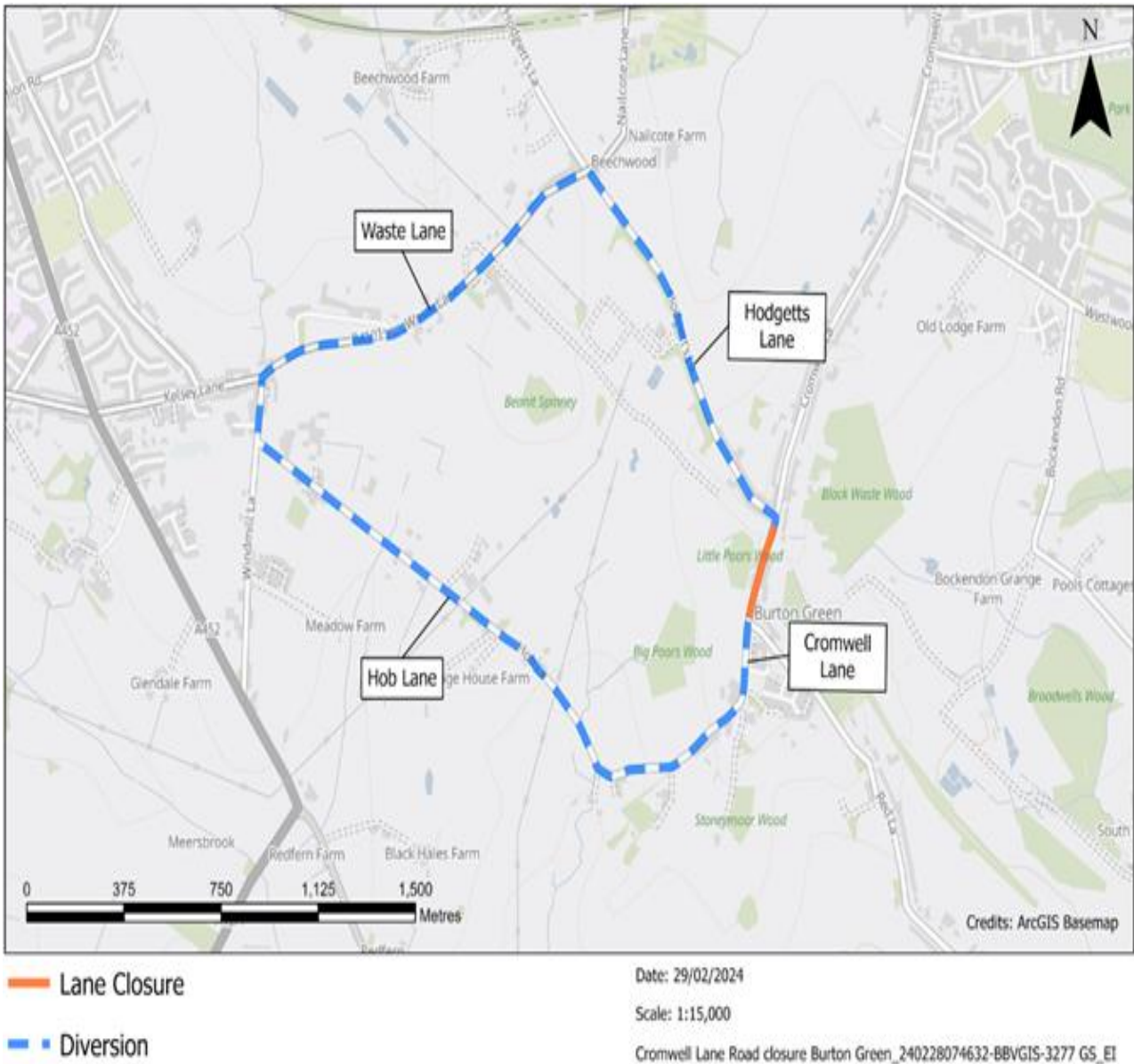
Some disruption to your travel times

A map showing the Cromwell Lane closure and signed diversion route.

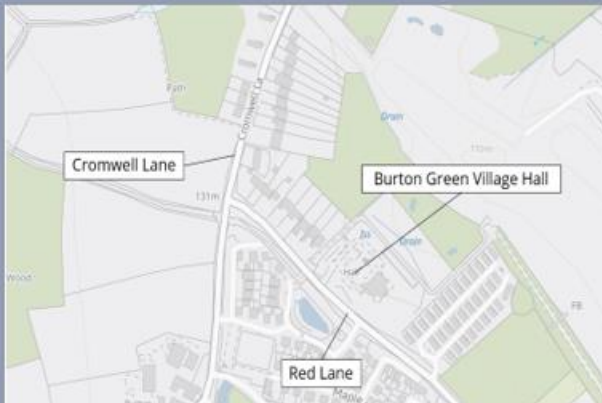


## We would like to invite you to a HS2 drop-in session at Burton Green Village Hall.
