## Notice of weekend closure of A452 Kenilworth Road -Meriden

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

#### The work we will be doing

The new railway will pass under a newly realigned Kenilworth Road between the Meriden Road Roundabout and Brandnocks Marsh (Aston Martin) Roundabout. There are a number of utilities that cross beneath the road in this location that need to be carefully diverted so that our works do not impact on the supply to residents and business.

You may already be aware that we have been working in the verges under lane closures. We now need to work in the central reservation and create a crossing point from one side of the carriageway to the other. Regrettably this can only be done under a full road closure.

To minimise the disruption, the team intend to work two intensive 48hour shifts during two weekends at the end of March and beginning of April. We will also utilise this time to bring forward other planned work to reduce the number of future closures.

Access to residents and business will be maintained throughout the closure and a fully signed diversion will be in operation. Please follow the directional signs.

#### When will this work take place

First closure - The traffic management will start at 6 am on Saturday 29 March and fully reopen at 6 am Monday 31 March 2025.

**Second closure** – The traffic management will start at 6am on Saturday 5 April and fully reopen at 6 am Monday 7 April 2025.


