

Notice of CCTV survey behind Woodhouse Avenue, Perivale

High Speed Two (HS2) is the new high speed railway for Britain.

What we are doing

From **Monday 18 to Friday 22 August 2025**, we will be carrying out a CCTV survey in the drainage system behind Woodhouse Avenue, Perivale. We will access the area through the gate on Scorton Avenue.

This survey will help us to understand the condition of the drainage system and how best to protect it during construction of the railway.

We will remove some overgrown vegetation to access the drainage system. We will then insert a camera, and we may need to use a jet washing machine to improve visibility for the camera.

How this may affect you

We will suspend three parking bays on Scorton Avenue and close off a small area of the road for storage. The jet washing machine, vans and equipment will be kept within this area.

You may hear some noise if we need to jet wash the drainage system. We will use noise reducing barriers where possible.

The approximate location of the work and storage area is shown on the map below. We apologise for any inconvenience this work may cause.
