



Updated- Extending period of temporary lane closures on A452 Chester Road – near Bickenhill

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing.

A new high-speed railway station is being built within Solihull, near the M42, A45 Coventry Road and A446 Stonebridge Road, close to the NEC, Birmingham Business Park and Birmingham Airport.

As we progress with our works on the highway network, we need to undertake ground investigations and utility diversion works.

When we will do the work.

To ensure the safety of road users and our workforce we have installed a series of lane closures on the A452 northbound and southbound carriageways.

We will extend the period of this traffic management as we continue to carry out our activities within this area.

The traffic management will now remain in place until Thursday 17 April 2025 between 9.30am to 3.30pm each day. We will alternate the lane closures as we progress works over this period.

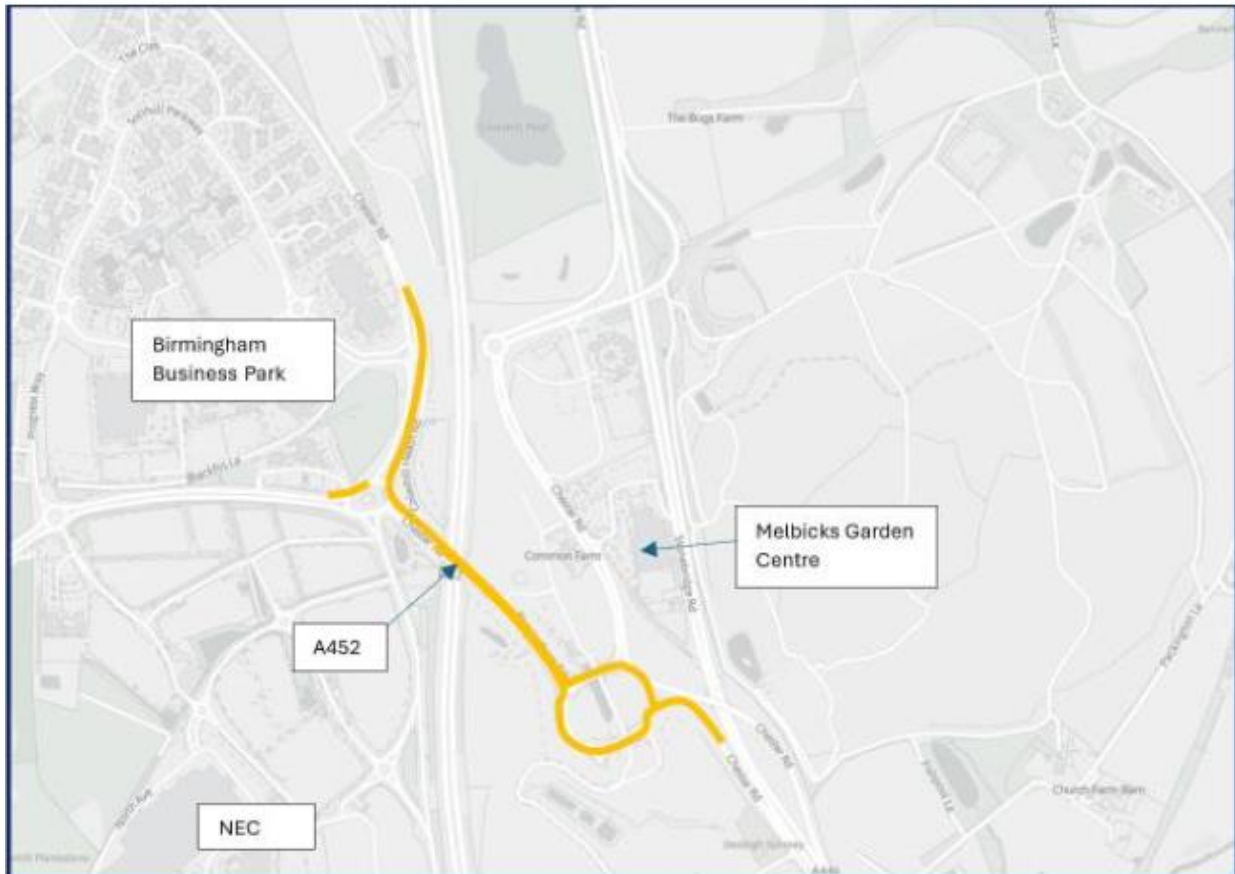
A452 Chester Road Lane closures
