#### What are we doing?

As part of the HS2 works, we are required to upgrade the local following Public Rights of Way (PRoW);

- GUN/24/1
- GUN/23/1
- EDG/12/1
- CAG/1/1
- CAG/4/3
- CAG/5/1

Upgrade works will include; new post & bridleway signs to be installed, localised vegetation to be trimmed, existing footpaths to be widened and stoned, ditch crossings to be cleaned and post and rail fences to be installed and repaired.

#### When will these works take place?

The above PRoW's will be closed from 24 March until 11 April 2025 for planned upgrade works to be completed.

Install and maintain local signs to inform people of temporary closures and diversions.


