# Notice of Lane Closure on Station Road and Quainton Road

## What are we doing?

To excavate bore holes in preparation for utilities works in advance of the eastern tie-in of the new realignment, there will be a lane closure on Station Road North, which will be controlled by temporary traffic lights.

This is for reasons of safety, as our operatives will be working on and around the carriageway.

## When will these works take place?

The lane closure on Station Road North will be controlled by temporary traffic lights and will be in place on Friday 4 April 2025 for one day only.

These dates may change due to conditions outside of our control, such as weather. Please refer to the HS2 website regularly to check for any changes and updates.

A lane closure will be in place on Station Road North, on Friday 4 April 2025 for one day only from 8.30am – 5.30pm. This date is included on the following map.

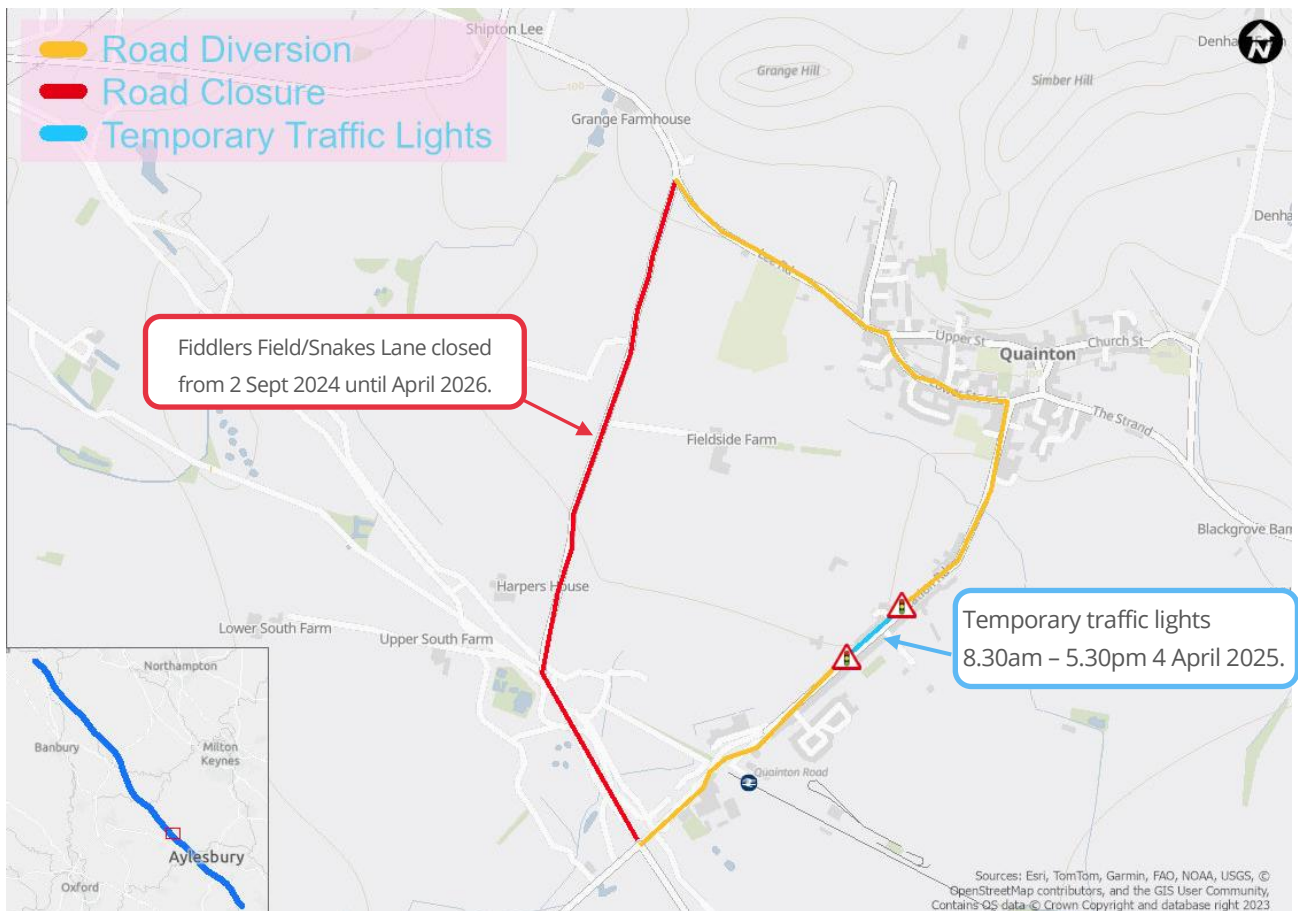
