



## **Notice of one overnight road closure on A38 Southbound, Lichfield from Hilliard's Cross junction to Cappers Lane junction first weekend in April**

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

### **Constructing a new Rykneld Street Overbridge**

As we build the new high speed railway line in Lichfield, we need to install a section of bridge to construct the new Rykneld Street Overbridge.

To lift the bridge into place safely, we need to close the A38 Southbound overnight from the Hilliard's Cross junction to Cappers Lane junction on Friday 4 April 2025 9.00pm to 6.00am each. These are earliest dates subject to change.

### **Southbound Diversion route**

To keep traffic moving in the area drivers will be diverted along Wood End Lane to A515 Tewnals Lane, along A51 Stafford Road to A5192 Eastern Avenue to rejoin the A38 carriageway. Access to businesses and properties will be maintained.

### **Travel times**

Travel times may be impacted due to the diversion routes and would advise road users to plan their journeys in advance. Where possible we would advise road users to consider the timings of their journeys as well as considering whether they need to drive or if they could use an alternative method of travel.

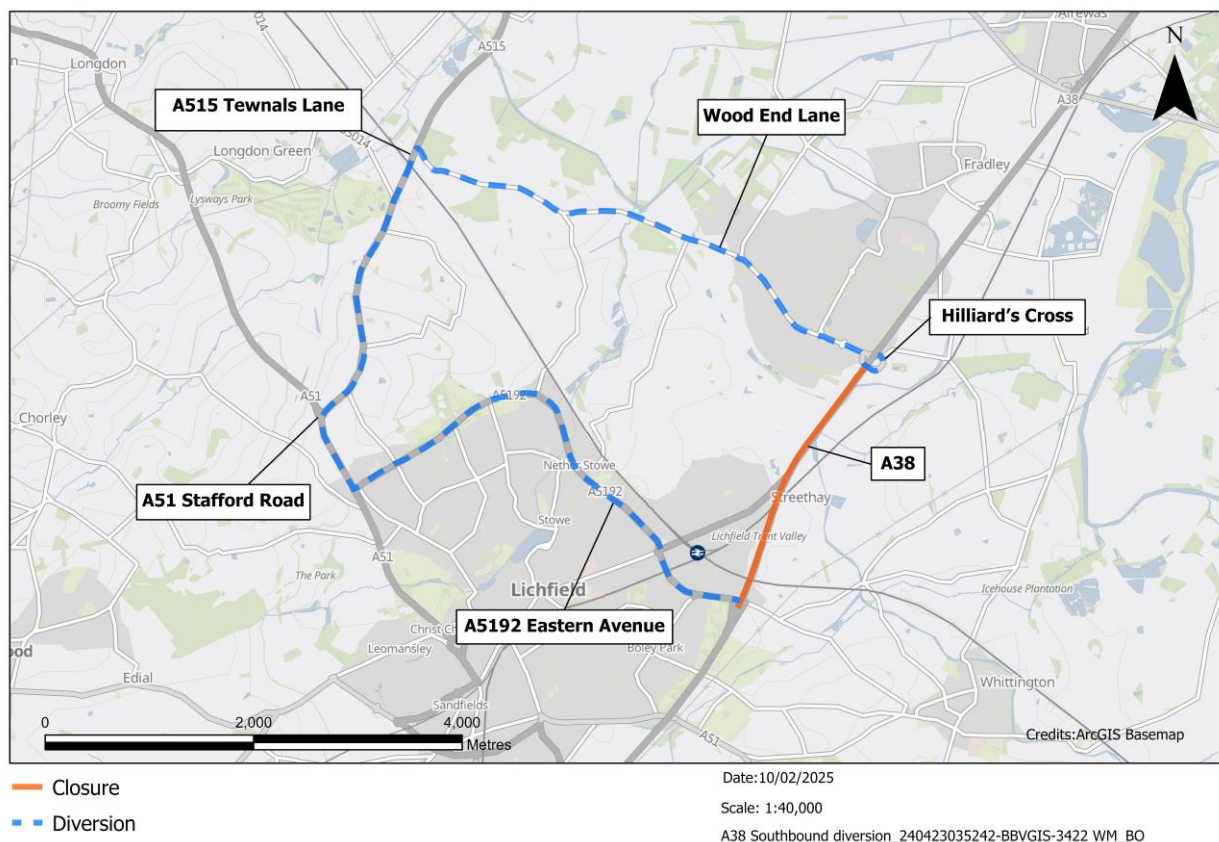
