



Notice of one overnight closure on A5 Hints Bypass Eastbound

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

Maintenance on the A5 Hints Bypass works area

We are working to construct the A5 Hints bypass Overbridge that will allow HS2 to pass under the A5. To continue the safe running of this roadworks scheme we will need to undertake maintenance works. To complete this work, we will need to close the Eastbound carriageway for one night on Monday 31 March 2025 9pm to 5am. The works will be monitored 24 hours a day in the event of incidents or breakdowns.

Eastbound Diversion route

To keep traffic moving in the area traffic wishing to travel Eastbound will need to follow the signed diversion route which will involve leaving the A5 at Weeford Roundabout, travel southbound along the A38 to Bassetts Pole Roundabout and then follow the A435 Sutton Road to rejoin the A5 at the Mile Oak junction and continue eastbound.

Travel times

Travel times may be impacted due to the diversion routes and would advise road users to plan their journeys in advance. Where possible we would advise road users to consider the timings of their journeys as well as considering whether they need to drive or if they could use an alternative method of travel.

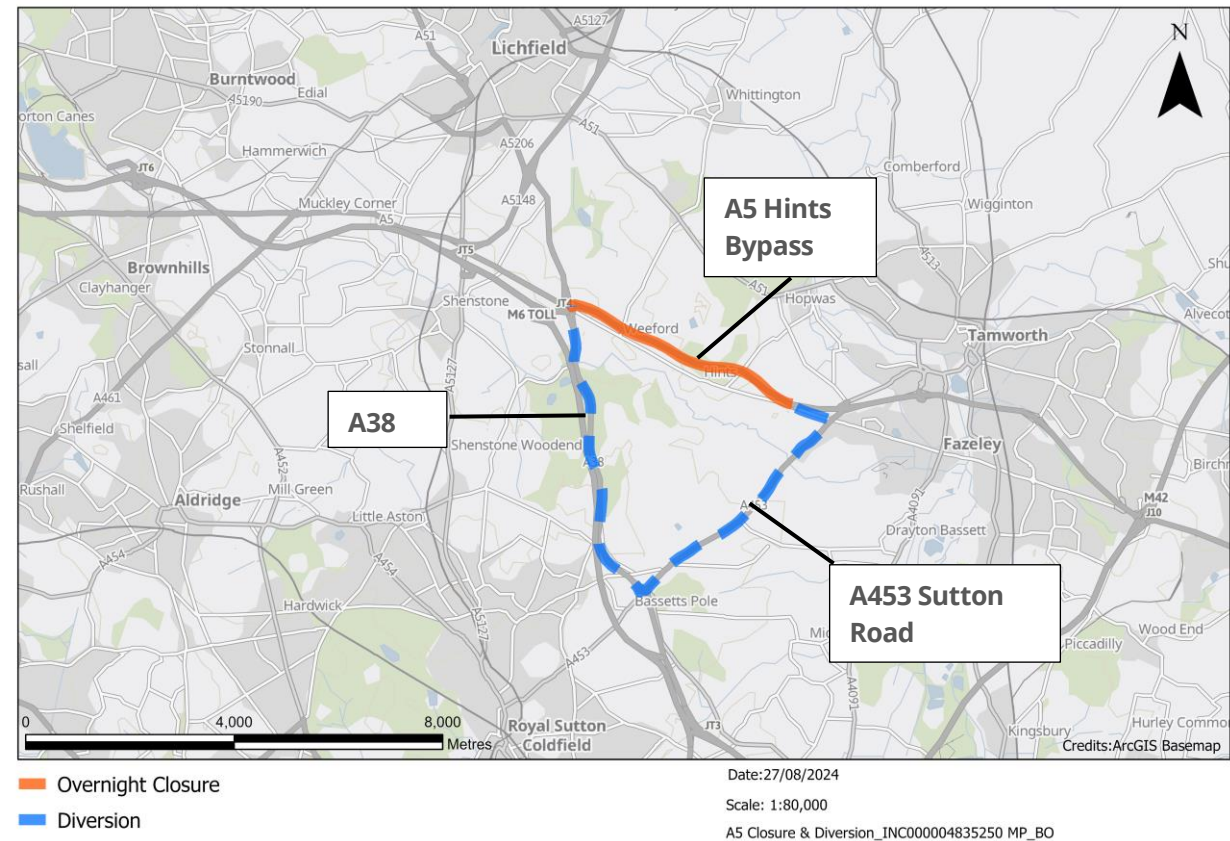
