High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we are doing

We are completing the final utility connections, vehicle safety system and central reservations, then remove all the traffic management ready to reopen the A46.

When the work will take place

We recently communicated that we would undertake these works overnight on the weekend of Saturday 16 and Sunday 17 August 2025. We have postponed these works due to a delay to a utility connection and plan to finish the work in October 2025. Once confirmed we will issue a communication with the new dates and diversion routes. As a contingency we will hold a second weekend in October in case of a further delay or inclement weather.
