

# **Update: change to end date** at our Mandeville Road site

High Speed Two (HS2) is the new high speed railway for Britain.

### Works to continue until summer 2027

The end date for our works at the Mandeville Road Headhouse and Vent Shaft site has moved from summer 2026 to summer 2027.

We need to carry out works to connect the shaft to the tunnels by removing a concrete slab at the bottom of the shaft. The dates for these works have changed due to coordination with other ongoing works along the tunnel route. There has also been an unexpected change to the headhouse construction method.

## Works on site in spring 2025

We're continuing works to build the main shaft and satellite shaft.

From April 2025, we'll start works to build the base slab for the headhouse. These works will include concrete pours. We'll also start installing reinforced concrete walls to build the headhouse.

Other works taking place on site during spring 2025 include:

- Installing the second tower crane
- General site maintenance and security
- Drainage works
- Deliveries and collections to and from site
