High Speed Two (HS2) is the new high speed railway for Britain. Mace Dragados is the Construction Partner building the new HS2 station in Euston.


Euston utility works

As part of our essential programme of works, we are continuing with utility works in the local area starting in April 2025 and continuing into the winter 2025.

Please read the rest of this notice to find out more about works taking place on Euston Street, Starcross Street, and South Cobourg Street.

Starcross Street UKPN Works

A new UKPN power station is being installed at the Maria Fidelis Old School site. To facilitate this, we will be extending our hoarding on Starcross Street, which will require the temporary suspension of two car park spaces. **These works will commence on Monday, 7 April 2025, and will last for ten weeks.**

Euston Street and North Gower Street Gas Works

Secondary gas diversions on Euston Street and North Gower Street will take place over three phases, with phase one beginning on Monday, 14 April 2025, and continuing until early September 2025. Working hours will be 8am - 5pm, Monday to Friday, with occasional extended hours and weekend work. Upon completion of each phase, traffic management will be reduced, and localised sites will be left to undertake commissioning.

Upcoming Drummond Street Works

Works to replace a gas main on Drummond Street will commence in late April 2025. These works will take place in four phases. During phase four, we will need to temporarily close Drummond Street to traffic from the junction of North Gower Street. We will write to you again to confirm the timing of these works.

Upcoming UKPN Works Cobourg Street footpath

To facilitate our ongoing UKPN activities Cobourg Street footpath will temporarily close from June 2025 for approximately 10 weeks. We will write to you again confirming the timing of these works.

What to expect during these works

We recognise that construction work can be disruptive to those living or working nearby. The nature of our work often means some disturbance is unavoidable, but please be assured that every effort is made to minimise any unnecessary noise. Please note that changes to the programme may occur and if these changes are likely to cause any disturbance, we will write to you again.

Works will include:

Worksites:

- Works surface area to be cut, broken out and excavated to the required depth using petrol powered floor saw, hydraulic breaker and vacuum excavator
- Acoustic blankets around worksites
- Dust suppression by spraying water onto any works producing dust

Working hours

- 8am to 5pm weekdays (excluding bank holidays)
- On occasions it may be necessary to work 8am to 6pm Saturday and Sundays as well as nighttime works on weekdays
- We will start-up and close-down activities up to one hour before after normal working hours above
