High Speed Two (HS2) is the new high speed railway for Britain.

Update to below ground works

We wrote to you in April 2025 about our works below ground to connect the ventilation shaft to the future HS2 tunnels from April to July 2025. These works are now expected to continue until **September 2025**. This is due to changes to our works method and programming.

We will be breaking concrete below ground. You may notice some ground-borne noise and vibration during these works.

We apologise for any inconvenience these works may cause.

Works programme

The programme of works at the Westgate Vent Shaft site for the remainder of the year is shown below.
