UPDATE: Notice of Road Closure on B4117 Gilson Road, Coleshill



High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

To continue our preparation for the construction of the HS2 railway, we will be installing traffic management on Gilson Road and Gilson Drive to undertake essential works in preparation for the new Gilson Road realignment. A full road closure will be in place on Gilson Road on the east side of the village, and traffic management will be in place on Gilson Drive north of the motorway bridge. These works will involve installing new kerbs, completing necessary drainage and carriageway surfacing.

When the work will take place.

To complete these works safely, we will install a full road closure along Gilson Road and traffic management on Gilson Drive from 8:00pm on Friday 04 April to 6:00am on Monday 07 April 2025. Access to properties and a pedestrian route will be maintained throughout the closure.
