



Notice of overnight lane closure of the northbound carriageway of the M42

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

As we prepare for construction of the new M42 triple box bridge across the M42 motorway, we will be carrying out works each month to allow our teams to clean the works area. These works will require overnight lane closures to access the works area safely.

To complete the works, we will be installing weekday overnight lane closures; lanes 3 and 4 of the northbound carriageway of the connector road from the M6 at J3a to where it joins the M42, and from J7a to J8.

When the work will take place

To ensure the safety of the road users and our workforce, we will install overnight lane closures from 9pm Tuesday 22 April to 5am on Wednesday 23 April.

This work is subject to consent with National Highways.
