



## Notice of traffic management on A446 Lichfield Road, Coleshill

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

### The work we will be doing

To continue our preparation for the construction of the HS2 railway, we will be completing works on the A446 Lichfield Road to allow us to install fencing in the verge.

To complete these works safely we will be closing a short section of one lane heading southbound on the A446 Lichfield Road at the junction of Gorsey Lane.

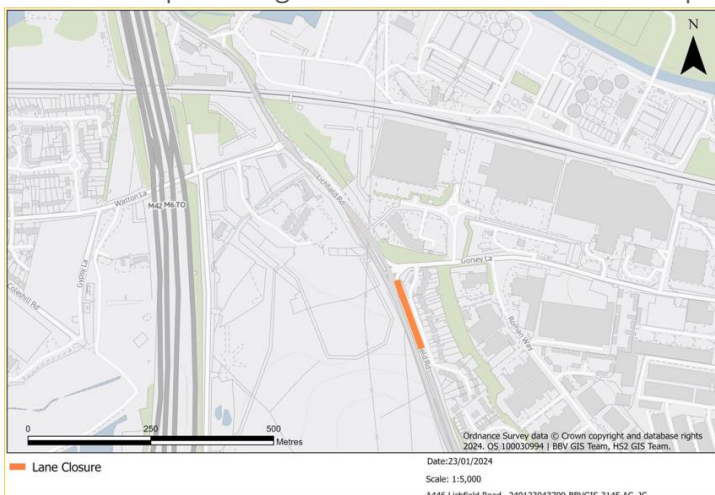
### When the work will take place

Traffic management will be in place on the A446 Lichfield Road, on Tuesday 6 May, from 9:30am to 13:30pm.

Turning into Gorsey Lane will still be possible and the main lanes on the A446 will not be affected.
