Update on concrete pours at Mandeville Road site

Concrete pours in July and August 2025

We wrote to you in April 2025 to let you know about deliveries to our Mandeville Road Ventilation Shaft site for concrete pours in May and June. We are writing now with an update about concrete pours planned in July and August.

We are planning five concrete pours in July and seven in August. These concrete pours are for works in the main shaft and to build the headhouse base slab. The works will take place in phases, shown as areas 1-6 on the map below. We will let you know when the dates are confirmed.

The concrete pours can take around 16 to 20 hours. We expect all the pours to start at 6am but they will have varied finish times.

There will be a delivery of machinery between 4am and 5am in advance of the concrete pour. The machinery will be removed once the concrete pour is complete. We will close Mandeville Road for about 15 minutes to reverse a lorry out of the site to remove the machinery.

While on-site work is not expected to cause additional disruption, there will be periods of noise from the concrete pour and concrete delivery vehicles. Traffic marshals will guide delivery vehicles as usual. Noise and vibration monitoring will also continue.
