Excavation and break out of concrete in the Satellite Shaft

We wrote to you in November 2024 to let you know we would be excavating and breaking concrete 22 metres below ground in the Satellite Shaft until late March. Half of these works have been completed, and the second half will take place from **28 April 2025 until 16 May 2025.**

How this will affect you

The works will be carried out using an excavator and concrete breaker in the shaft. You may notice vibration and noise from the construction machinery.

We will use noise reducing barriers to help keep noise and vibration to a minimum. We will work as efficiently as possible, while keeping our work areas safe and tidy.

We would like to apologise for any disruption or inconvenience this may cause. Every effort is being taken to ensure that these works are carried out in the least impactful way.
