High Speed Two (HS2) is the new high speed railway for Britain.

Site entrance work starting this month

We will be installing utility cables and pipes just inside the main entrance to the Old Oak Common station site. This involves excavating trenches, installing services, re-filling the trenches and reinstating the road surface. There may be some noise from the machinery used and fencing and noise barriers will be in place. This work to re-route cables and pipes is a key part of the preparation for the new Old Oak Common station.

This work will take place over weekends and bank holidays:

- Friday 18 April to Monday 21 April (Easter weekend): 8am-
- Saturday 26 and Sunday 27 April: 8am-1pm
- Saturday 3 and Sunday 4 May: 8am-7pm
- Monday 5 May (bank holiday): 8am-7pm
- Saturday 10 and Sunday 11 May: 8am-1pm

We need to use public holidays and weekends when there will be no deliveries to the site.
