

# **Temporary traffic lights on B485 Chesham Road, South Heath, Bucks**

High Speed Two (HS2) is the new high speed railway for Britain. This notification is to inform you of works requiring temporary traffic lights on Chesham Road, B485, South Heath, Buckinghamshire.

### What are we doing?

We will be working to change the temporary bell mouth at our Chesham Road site, on the B485 Chesham Road, near South Heath to create the permanent site entrance and access road. The bell mouth will remain in the same location however, the width and alignment of the access road will be changed. Works will take place:

- From Tuesday 6 May to Tuesday 20 May 2025
- Monday to Saturday from 8am to 10pm (subject to approval)

### How will this affect you?

A single lane closure on B485 Chesham Road is required to undertake these works, managed by temporary traffic lights across the bell mouth.

Traffic management will remain in place for the duration of work, including outside the working hours to control traffic and ensure that operatives can work safely in the carriageway.

### **Duration of works**

Two-way temporary traffic lights from Tuesday 6 May to Tuesday 20 May 2025

Monday to Saturday 8am to 10 pm (subject to approval)

### What to expect

- Single lane closure
- Waiting times to be expected at the 24/7 traffic lights
- Fully signed traffic management and temporary traffic signals
- Operatives working in the highway

### What we will do

- Keep you updated with any changes
- Inform residents, village associations and schools
- Remove the traffic management as soon as possible
- Keep the footpath open
