



Single lane closures on Frith Hill, Great Missenden


High Speed Two (HS2) is the new high speed railway for Britain. This notification is to inform you of some works on Frith Hill that will require two separate areas of single lane closure at the same time.

What are we doing?

Following on from previous cable testing works, UK Power Network (UKPN) will be conducting repair works to existing underground cables on Frith Hill and connecting power to our North Portal site. This requires two single lane closures along Frith Hill while works are underway.

There will be one single lane closure which will be managed with temporary two-way traffic lights while the other with priority traffic system to ensure traffic flow is safely maintained. UKPN will send out their own notice prior to these works to confirm working hours.

These works are not being carried out by Align JV and times and dates may be subject to late changes.

Duration of works

Traffic management and works will take place between mid April and the end of May 2025. Please note that these dates may be subject to change at late notice.

What to expect

- Two single lane closures on Frith Hill by areas of works
- Fully signed traffic management and temporary traffic signals
- Communications from UK Power Networks for neighbouring residents

What we will do

- Inform local Parish councils, village associations and schools
- Reopen the lane as soon as possible
