High Speed Two (HS2) is the new high speed railway for Britain.

#### **Cable route from Lidlington Place to Varndell Street**

We have been diverting utility services on and next to Hampstead Road, to clear our working area before we begin works to extend Hampstead Road bridge.

We previously installed a new cable route from Lidlington Place to Varndell Street via Granby Terrace, to replace the existing route next to Hampstead Road.

Now that we have installed the ducting which will form the cable route, the next stage is to pull the cables through the pipes. We do this by pulling cables between underground cable joint bays located on the route.

From **May to December 2025**, we will work Monday to Friday, 8am to 6pm, Saturdays from 8am to 5pm and Sundays from 10am to 5pm. To reduce impacts to residents, there will be no breaking concrete after 1pm on Saturdays and no noisy works on Sundays.

We will minimise noise impacts where practicable to ensure we are working within the approved limits.

The cable pulling will be done in seven phases, please see table on **page 3** for details.

We apologise for any disruption these works may cause.

#### First phases from 6 May 2025



#### **Lane closure on Lidlington Place**

From 6 May to late June, we will close a section of the carriageway and northern footpath on Lidlington place between Eversholt Street and Harrington Square.

We will provide a signposted pedestrian diversion and property access will be maintained at all times.

We will also work within our existing traffic management on Hampstead Road, with a back-to-back closure of one southbound and one northbound lane



#### **Road closure on Stanhope Street**

From 6 May to early July, we will close Stanhope Street north of the junction with Varndell Street. We will also close a section of the eastern footpath. Pedestrians will be diverted to the western footpath.

We will work within our current traffic management on Hampstead Road close to the junction of Varndell Street.

Traffic will be diverted via Mackworth Street, Harrington Street and Varndell Street.

Property access will be maintained at all times.

#### Seven phases of utilities diversion work

We will update you with further detail of the works in these phases nearer the time.

Phase 1	Lane closures on Hampstead Road, lane and footpath closure on Lidlington Place	06/05/2025 to 27/06/2025
Phase 2	Road closure on Stanhope Street north of Varndell Street	06/05/2025 to 18/07/2025
Phase 3	Road closure on Stanhope Street across Varndell Street	30/07/2025 to 08/08/2025
Phase 4	Road closure on Stanhope Street north of Varndell Street, lane and footpath closure on Stanhope Street close to Cubitt Court	19/09/2025 to 21/10/2025
Phase 5	Lane and footpath closure on Stanhope Street close to Cubitt Court, and working area close to Oxenholme	21/10/2025 to 05/11/2025
Phase 6	Lane and footpath closure on Stanhope Street close to Cubitt Court, Lane closures on Hampstead Road	14/11/2025 to 11/12/2025
Phase 7	Road closure on Stanhope Street and southbound lane closure on Hampstead Road	September 2025 (TBC)

#### Lane closure on Stanhope Street for utility work - 28 April to 27 May 2025

We previously informed you we will install ducts in the road and footpath outside our site access gate at the junction of Stanhope Street and Park Village East. These works will now start on **28 April 2025**. We expect these works to take five weeks to complete.

To complete this work, we will install a 2-way set of temporary traffic lights to control the flow of traffic with crossing points at either end of the worksite to divert pedestrians to the opposite footpath. We will complete the work in two phases, first closing the northbound lane and then switching to close the southbound lane. Once utility works are complete, we will install a new gate to the Stanhope Street site access.

We will maintain pedestrian access at all times, however, while we are working in the northbound lane and footpath, access into Cubitt Court will be from the north. We will suspend several parking bays on Stanhope Street to carry out this work, however, all parking bays will remain open outside Cubitt Court. We apologise for any inconvenience these works may cause.
