High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

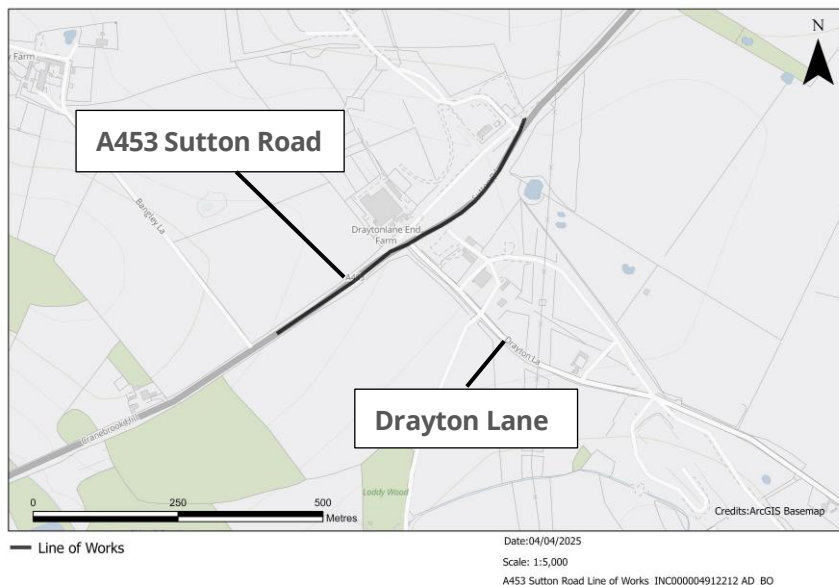
The work we are completing

We have previously undertaken works to realign A453 Sutton Road to allow for the construction of Sutton Road Overbridge. This will allow HS2 to pass underneath the road at this location. As part of our ongoing maintenance works, we are installing digital speed road signage. To carry out these works safely we need to create a safe working area which will require us to install temporary traffic lights.

When will the work take place

We will have temporary traffic lights in place between 9.30am to 3.30pm on Tuesday 6 May.

Due to the nature of the works, the location of the traffic lights, in our works area on A453 Sutton Road may change during the day.
